**COMMUNITY LAND**

**The Compulsory Acquisition by Public Authorities  
(Compensation) Amendment (Scotland) Order 1976**

*Laid before Parliament in draft*

*Made - - - 21st December 1976*

*Coming into Operation 14th January 1977*

In exercise of the powers conferred on me by sections 26(1), (3) and (4) and 53(2) and (3) of the Community Land Act 1975(a), and of all other powers enabling me in that behalf, and with the consent of the Treasury, I hereby make the following order in the terms of a draft which has been laid before and approved by a resolution of each House of Parliament:—

*Citation, application, commencement and interpretation*

**1.—(1)** This order may be cited as the Compulsory Acquisition by Public Authorities (Compensation) Amendment (Scotland) Order 1976 and the Compulsory Acquisition by Public Authorities (Compensation) Order 1976(b) and this order may be cited together as the Compulsory Acquisition by Public Authorities (Compensation) (Scotland) Orders 1976.

(2) This order applies to Scotland.

(3) This order shall come into operation on 14th January 1977.

(4) The Interpretation Act 1889(c) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

*Amendment of the Compulsory Acquisition by Public Authorities (Compensation) Order 1976*

**2.** The Compulsory Acquisition by Public Authorities (Compensation) Order 1976 is hereby amended as follows:—

In Article 3 there shall be added to the list of bodies specified for the purposes of paragraphs (b) and (c) of section 26(1) of the Community Land Act 1975—

“The council of a district in Scotland which is within the area of a general planning authority, as defined in section 172 of the Local Government (Scotland) Act 1973”(d).
