**The Import Duties (Temporary Reductions and Exemptions)  
(No. 6) Order 1976**

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 3(6) and 13 of the Import Duties Act 1958(a), as amended by section 5(5) of, and paragraph 1 of Schedule 4 to, the European Communities Act 1972(b), and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State (c), hereby make the following Order:

**1.—(1)** This Order may be cited as the Import Duties (Temporary Reductions and Exemptions) (No. 6) Order 1976 and shall come into operation on 29th March 1976.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**2.—(1)** In Article 2 of the Import Duties (Temporary Reductions and Exemptions) Order 1976(e) for "28th March 1976" there shall be substituted "30th April 1976".

(2) In Article 7 of the Import Duties (Temporary Reductions and Exemptions) (No. 4) Order 1976(f) for "28th March 1976" there shall be substituted "15th April 1976" and from "and seed potatoes" onwards shall be deleted.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order, which comes into operation on 29th March 1976, amends the Import Duties (Temporary Reductions and Exemptions) Order 1976 by extending the exemption from import duty up to and including 30th April 1976 in the case of potatoes falling within tariff subheading 07.01 A.III b)2.

It also amends the Import Duties (Temporary Reductions and Exemptions) (No. 4) Order 1976, by extending the exemption from import duty up to and including 15th April 1976 in the case of new potatoes.

These potatoes are subject to total suspension of duty in the Common Customs Tariff of the European Economic Community for the periods in question and the exemptions are made in accordance with the United Kingdom's Community obligations.
