# Act of Sederunt (Rules of Court Amendment No. 7) (Solicitor's Admission Fees) 1976

Made - - -

2nd June 1976

Coming into Operation

30th June 1976

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 16 of the Administration of Justice (Scotland) Act 1933(a) and section 18 of the Solicitors (Scotland) Act 1933(b) and of all other powers competent to them in that behalf, do hereby enact and declare:—

Citation, commencement and interpretation

1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Rules of Court Amendment No. 7) (Solicitor's Admission Fees) 1976 and shall come into operation on 30th June 1976.

(2) The Interpretation Act 1889(c) shall apply to the interpretation of this Act of Sederunt as it applies to the interpretation of an Act of Parliament.

Amendment of rules 2 and 3 (admission fees of solicitors)

- 2. In the Rules of Court (d)—
  - (a) in rule 2, for heads (i) and (ii) of paragraph (a), substitute the following heads:—
    - "(i) for the preparation of and carrying through the Petition under section 14 of the Act of 1933, including the issue of the Certificate of Fitness by the Council, Certificate of Exemption from the Society's examinations, obtaining the interlocutor of admission, extract thereof and Certificate of Enrolment, where the applicant holds the certificate of the Council—£30;
    - (ii) for the preparation and carrying through the Petition under the said section 14 including the issue and obtaining of the certificates and other documents mentioned in head (i), where the applicant holds a qualified certificate of the Council—£40;
    - (iii) for obtaining the interlocutor of admission of an applicant under section 15 of the Act of 1933, including extract thereof of Certificate of Enrolment—£10."
  - (b) in rule 3, in paragraph (a), omit the words from "and there shall be payable" to the end of the paragraph.
