**The Social Security (Contributions, Re-rating) Consequential
Amendment Regulations 1977**

<i>Made - - - -</i>	<i>26th January 1977</i>
<i>Laid before Parliament</i>	<i>27th January 1977</i>
<i>Coming into Operation</i>	<i>6th April 1977</i>

The Secretary of State for Social Services in exercise of the powers conferred upon him by section 129 of, and paragraph 4(a) of Schedule 1 to, the Social Security Act 1975(a) and of all other powers enabling him in that behalf, hereby makes the following regulations which are made for the purpose of making provision consequential on the Social Security (Contributions, Re-rating) Order 1977(b) and contain only provisions in consequence of that Order and the National Insurance Surcharge Act 1976(c).

Citation, interpretation and commencement

1. These regulations, which may be cited as the Social Security (Contributions, Re-rating) Consequential Amendment Regulations 1977, shall be read as one with the Social Security (Contributions) Regulations 1975(d) as amended (e) (hereinafter referred to as "the principal regulations") and shall come into operation on 6th April 1977.

Amendment of regulations 1(2) and 77 of the principal regulations

2. In regulations 1(2) and 77 of the principal regulations (interpretation) after the definition "Re-rating Order 1975" there shall in each of those regulations be inserted the following definition:—

“The Re-rating Order 1977” means the Social Security (Contributions, Re-rating) Order 1977;

Amendment of regulation 88A of the principal regulations

3. At the beginning of regulation 88A of the principal regulations (transitional provisions consequent upon the Re-rating Order 1975) there shall be inserted the words "Subject to the provisions of the next succeeding regulation".

Insertion of regulation 88B of the principal regulations

4. After regulation 88A of the principal regulations there shall be inserted the following regulation—

“Transitional provisions consequent upon the Re-rating Order 1977

88B. As respects any payment of earnings made on or after 6th April 1977 (the date on which the Re-rating Order 1977 comes into operation) to or for the benefit of a mariner for his employment as such during the voyage period, the provisions of the Re-rating Order 1977 shall not apply in the cases and to the extent specified in the next two succeeding paragraphs and in those cases the contributions payable shall be calculated as if the Re-rating Order 1977 had not been made:—

- (a) in the case of employment during a voyage period which begins before 6th March 1977 and ends before 6th May 1977, to the extent of the whole of the earnings for that employment;
- (b) in the case of employment during a voyage period which begins before 6th March 1977 and ends on or after 6th May 1977, to the extent of so much of the earnings as relates to that part of the employment which occurs before 6th April 1977.”

Amendment of regulation 89 of the principal regulations

5. In regulation 89(c) of the principal regulations (modification in relation to share fishermen of Part I of the Act and so much of Part IV thereof as relates to contributions) for “£3·21” there shall be substituted “£3·62”.

Substitution for Schedules 1, 4 and 6 to the principal regulations

6. For Schedules 1, 4 and 6 to the principal regulations (weekly and monthly scales of contributions under the Act at the standard rate and reduced rate and at the respective rates appropriate for mariners and members of the forces) there shall respectively be substituted the Schedules set out in Schedules A, B and C to these regulations.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Social Security (Contributions) Regulations 1975 and are made for the purpose of making provision consequential on the Social Security (Contributions, Re-rating) Order 1977, and contain only provisions in consequence of that Order and the National Insurance Surcharge Act 1976. Accordingly, by virtue of section 167(2) of the Social Security Act 1975 no draft of the Regulations has been laid before Parliament for approval by resolution of each House; and by virtue of section 1(4) of the National Insurance Surcharge Act 1976 no reference has been made to the National Insurance Advisory Committee.

The Regulations make provision for contributions payable in respect of mariners' earnings paid on or after 6th April 1977 to be charged in certain circumstances on the basis of the earnings limits which would have been appropriate if the Re-rating Order 1977 had not been made.

The Regulations also increase the rate of contribution payable by share fishermen and substitute scales of contributions which take account of the new earnings limits imposed by the Re-rating Order 1977 and of the surcharge on secondary Class 1 contributions imposed by the National Insurance Surcharge Act 1976.
