INDUSTRIAL TRIBUNALS

The Industrial Tribunals (Amendment) Regulations 1977

Made - - - - 1st September 1977

Laid before Parliament 12th September 1977

Coming into Operation 25th October 1977

The Secretary of State in exercise of the powers conferred on him by section 12 of the Industrial Training Act 1964(a) and by paragraph 21(1) of Schedule 1 to the Trade Union and Labour Relations Act 1974(b) and after consultation with the Council on Tribunals hereby makes the following Regulations amending the Industrial Tribunals (England and Wales) Regulations 1965(c), as amended(d), (hereinafter referred to as "the principal Regulations"):

Citation, commencement and revocation

1.—(1) These Regulations may be cited as the Industrial Tribunals (Amendment) Regulations 1977 and shall come into operation on 25th October 1977.

(2) The Industrial Tribunals (England and Wales) (Amendment) Regulations 1971(e) shall cease to have effect.

Interpretation

2. The Interpretation Act 1889(f) shall apply to these Regulations as it applies to an Act of Parliament as if these Regulations and the Regulations hereby revoked were Acts of Parliament.

Amendment of principal Regulations

3. For paragraph (3) of Regulation 5 of the principal Regulations there shall be substituted the following paragraph:—

“(3) For each hearing the two members of a tribunal other than the chairman shall be selected by the President (or by a member of the panel of chairmen for the time being nominated by the President for the purpose), as to one member from a panel of persons appointed by the Secretary of State after consultation with any organisation or association of organisations representative of employers, and as to the other member from a panel of persons appointed by the Secretary of State after consultation with any organisation or association of organisations representative of employed persons.”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations, which come into force on 25th October 1977, amend the Industrial Tribunals (England and Wales) Regulations 1965, as previously amended, by revoking the Industrial Tribunals (England and Wales) (Amendment) Regulations 1971, thereby restoring the provision as respects the constitution of the Industrial Tribunals (England and Wales) to what it was before the amendment of 1971.
