## HIGH COURT OF JUSTICIARY, SCOTLAND

## Act of Adjournal (Circuits) 1977

Made - - - 14th October 1977 Coming into Operation 18th November 1977

The Lord Justice General, Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred upon them by section 114 of the Criminal Procedure (Scotland) Act 1975(a), and of all other powers competent to them in that behalf, and after consultation with the Lord Advocate, do hereby enact and declare:

Citation, commencement and interpretation

- 1.—(1) This Act of Adjournal may be cited as the Act of Adjournal (Circuits) 1977 and shall come into operation on 18th November 1977.
- (2) The Interpretation Act 1889(b) shall apply to the interpretation of this Act of Adjournal as it applies to the interpretation of an Act of Parliament.
- (3) In this Act of Adjournal, "Clerk of Justiciary" has the meaning assigned to it by section 462(1) of the said Act of 1975.

#### Places and times of circuits

- 2.—(1) The circuits and sittings specified in column 1 of schedule 1 to this Act of Adjournal shall be held during 1978 at the places, on the dates and at the times specified respectively in relation thereto in columns 2, 3 and 4 of that schedule.
- (2) Intimation thereof shall be made by the Clerk of Justiciary to all sheriff clerks on the passing of this Act of Adjournal in such form as he considers appropriate.

#### Jury Lists

- 3.—(1) The Clerk of Justiciary may require any sheriff on the issue of a requisition notice by him to return to him in accordance with the provisions of this paragraph a list of persons qualified and liable to serve as jurors for the purposes of the circuits and sittings mentioned in paragraph 2.
- (2) Unless the requisition notice otherwise directs, those lists shall, in respect of each place specified in column 1 of schedule 2 to this Act of Adjournal, consist of such number of persons from the sheriff court districts specified opposite that place in column 2 of that schedule as is specified opposite that district in column 3 of that schedule.

#### Revocation

- 4. The following Acts of Adjournal are revoked—
  - (a) Act of Adjournal (Sittings of the High Court of Justiciary, Glasgow) 1967(a);
  - (b) Act of Adjournal (Sittings of the High Court of Justiciary on Circuit) 1971(b).

And the Lords appoint this Act of Adjournal to be recorded in the Books of Adjournal.
