

## 1977 No. 1745

**LOCAL GOVERNMENT, ENGLAND AND WALES**  
**The Local Government (Allowances) (Amendment) (No. 2)**  
**Regulations 1977**

*Made - - - - - 27th October 1977*  
*Laid before Parliament 28th October 1977*  
*Coming into Operation 18th November 1977*

The Secretary of State for the Environment and the Secretary of State for Wales in exercise of the powers conferred on them by sections 173 and 178 of the Local Government Act 1972(a) and of all other powers enabling them in that behalf, hereby make the following regulations in relation, respectively to England and to Wales:—

*Title and Commencement*

**1.** These regulations may be cited as the Local Government (Allowances) (Amendment) (No. 2) Regulations 1977 and shall come into operation on 18th November 1977.

*Interpretation*

**2.** The Interpretation Act 1889(b) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

*Increase in Rates of Attendance Allowance and Financial Loss Allowance*

**3.** In regulation 3 of the Local Government (Allowances) Regulations 1974(c) as amended(d)—

(a) in paragraph (1) (which prescribes the rate of attendance allowance) for the figure “£10” there shall be substituted the figure “£11”, and

(b) for paragraph (2) (which prescribes the rate of financial loss allowance) there shall be substituted the following:—

“(2) The prescribed amount of financial loss allowance shall be—

(a) if the period of entitlement does not exceed 4 hours, £5.38;

(b) if the period exceeds 4 hours but does not exceed 24 hours, £10.75;

(c) if the period exceeds 24 hours, £10.75 for each complete 24 hours plus the rate appropriate to the remainder of the period.”.

EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations increase the maximum rates of attendance allowance payable to members of a local authority and financial loss allowance payable to any member of a body to which section 173 of the Local Government Act 1972 applies, and who is not entitled to attendance allowances for the performance of approved duties.
