**The Norway Pout (Prohibition of Fishing) (No. 3) Order 1977**

<i>Made - - - -</i>	<i>31st October 1977</i>

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fishing industry in Scotland and Northern Ireland, in exercise of the powers conferred on them by the following sections of the Sea Fish (Conservation) Act 1967(a) namely, sections 5(1) and (2), 15 and 20 (as section 15 is amended by section 22(1) of and paragraph 38(3) of Schedule 1 to the Sea Fisheries Act 1968(b) and as sections 5(2) and 15 are amended by section 9(1) of and paragraph 16(1) of Schedule 2 to the Fishery Limits Act 1976(c)) and of all other powers enabling them in that behalf, hereby make the following order:—

*Citation and commencement*

1. This order may be cited as the Norway Pout (Prohibition of Fishing) (No. 3) Order 1977 and shall come into operation on 1st November 1977.

*Interpretation*

2. The Interpretation Act 1889(d) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament and as if the order hereby revoked and this order were Acts of Parliament.

*Revocation of previous order*

3. The Norway Pout (Prohibition of Fishing) (No. 2) (Order) 1977(e) is hereby revoked.

*Prohibition*

4. On and after 1st November 1977, the fishing for Norway pout (*Trisopterus esmarkii*) within the area of the North Sea specified in the Schedule to this order is hereby prohibited.

5. In accordance with section 5(3) of the Sea Fish (Conservation) Act 1967 it is hereby declared that this order is not made for the sole purpose of giving effect to such a convention or agreement as is mentioned in section 5(1) of that Act.

*Enforcement*

6. For the purpose of the enforcement of this order, there are hereby conferred on every British sea fishery officer the powers of a British sea fishery officer under section 8(2) to (4) of the Sea Fisheries Act 1968 as subsection (4) is amended by section 9(1) of and paragraph 17(1) of Schedule 2 to the Fishery Limits Act 1976.

**SCHEDULE**

The area of the North Sea bounded on the south by a line running due east from a point on the coast of Scotland at 56°00' north latitude to the Greenwich meridian; thence due north to the parallel of 60°00' north latitude; thence due west to the meridian of 03°00' west longitude; thence due south to the parallel of 58°30'; thence due west to the coast of Scotland.

**EXPLANATORY NOTE**

*(This Note is not part of the Order.)*

This Order, which is designed to protect stocks of fish for human consumption which are taken as a by catch in the Norway pout fishery provides that from 1st November 1977 the fishing for Norway pout in an area of the North Sea adjoining the east and north coasts of Scotland is prohibited. By virtue of Section 5(8) of the Sea Fish (Conservation) Act 1967, the Order applies to all fishing boats including foreign vessels.

This Order revokes the Norway Pout (Prohibition of Fishing) (No. 2) Order 1977.
