## WATER, ENGLAND AND WALES

The Severn-Trent Water Authority (Coventry, North East Warwickshire, North West Gloucestershire and Nottingham) (Extension of Operation of Byelaws) Order 1977

> 29th November 1977 Made -Coming into Operation 12th December 1977

The Secretary of State for the Environment, in exercise of powers conferred by the proviso to section 19(6) of the Water Act 1945(a) and now vested in him(b), and of all other powers enabling him in that behalf, hereby orders as follows:-

- 1. This order may be cited as the Severn-Trent Water Authority (Coventry, North East Warwickshire, North West Gloucestershire and Nottingham) (Extension of Operation of Byelaws) Order 1977 and shall come into operation on 12th December 1977.
  - 2. In this order, unless the context otherwise requires— "byelaws" means byelaws made under section 17 of the Water Act 1945; "the order of 1976" means the Severn-Trent Water Authority (Coventry and Nottingham) (Extension of Operation of Byelaws) Order 1976(c).
- 3. The byelaws made on 19th March 1964 by the lord mayor, aldermen, and citizens of the City of Coventry acting by the council of that city, which byelaws would, by virtue of the order of 1976, remain in force until 18th March 1978, shall remain in force until 18th March 1979.
- 4. The byelaws made on 6th June 1967 by the North East Warwickshire Water Board, which byelaws would, by virtue of the Severn-Trent Water Authority (North East Warwickshire) (Extension of Operation of Byelaws) Order 1977(d), remain in force until 31st December 1977, shall remain in force until 31st December 1978.
- 5. The byelaws made on 13th February 1967 by the North West Gloucestershire Water Board, which byelaws would, by virtue of the Severn-Trent Water Authority (North West Gloucestershire) (Extension of Operation of Byelaws) Order 1977(e), remain in force until the 12th February 1978, shall remain in force until 12th February 1979.
