FOREIGN COMPENSATION

The Foreign Compensation (Financial Provisions) Order 1977

Made - - - - 16th February 1977
Laid before Parliament 24th February 1977
Coming into Operation 21st March 1977

At the Court of Saint James, the 16th day of February 1977

Present,

The Counsellors of State in Council

Whereas Her Majesty, in pursuance of the Regency Acts 1937 to 1953, was pleased, by Letters Patent dated the 3rd day of February 1977, to delegate to the six Counsellors of State therein named or any two or more of them full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval for anything for which Her Majesty's approval in Council is required:

Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Prince Charles, Prince of Wales, being authorised thereto by the said Letters Patent, and in pursuance of the powers conferred by section 7(2) of the Foreign Compensation Act 1950(a) and section 3(3) of the Foreign Compensation Act 1962(b) or otherwise in Her Majesty vested, and by and with the advice of Her Majesty's Privy Council, do on Her Majesty's behalf order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as the Foreign Compensation (Financial Provisions) Order 1977 and shall come into operation on 21st March 1977.
- 2. The Foreign Compensation Commission shall pay into the Exchequer not later than 30th March 1977 out of each of the Funds named in Column 1 of the Schedule to this Order the amount specified in respect of that Fund in Column 2 of the Schedule which is hereby determined to be the amount of the expenses of the Commission during the period 1st October 1975 to 30th September 1976 attributable to the discharge by the Commission of their functions in relation to the distribution of sums from that Fund.
