# The Judicature (Northern Ireland) Act 1978 (Commencement No. 1) Order 1978

Made - - - 24th July 1978

The Lord Chancellor, in exercise of the powers conferred on him by section 123(2) and (3) of the Judicature (Northern Ireland) Act 1978(a) (hereinafter referred to as "the Act"), hereby makes the following Order:—

- 1.—(1) This Order may be cited as the Judicature (Northern Ireland) Act (Commencement No. 1) Order 1978.
- (2) The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. Subject to Article 3 and to the limitations mentioned in the first column of the Schedule hereto the provisions of the Act specified in that Schedule shall come into force on 21st August 1978.
- 3. Section 53 of the Act shall, until the day appointed for the coming into force of section 70(1) of the Act, have effect with the substitution for paragraph (e) of the following paragraph—
  - "(e) the Registrar of the Supreme Court;".
