## BUILDING SOCIETIES

## The Building Societies (Fees) Regulations 1978

<i>Made - - - -</i>	1st December 1978
<i>Laid before Parliament</i>	11th December 1978
<i>Coming into Operation</i>	1st January 1979

The Chief Registrar of Friendly Societies, with the consent of the Treasury, pursuant to the powers conferred upon him by section 123(1) of the Building Societies Act 1962(a), and to all other powers enabling him in that behalf, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Building Societies (Fees) Regulations 1978 and shall come into operation on 1st January 1979.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.

2. The Building Societies (Forms and Fees) Regulations 1962(c) shall be amended by substituting for Schedule 2 thereto the following Schedule:—

For registration of a transfer of engagements, where the transferring society, whether or not registered, or deemed to be registered, in Northern Ireland, has—	
(a) 1,000 members or less .. .. .	260.00

For confirmation of a union or transfer of engagements .. .. .	32.50
and if more than one hearing, or an adjournment, becomes necessary, then £26 more for every hearing after the first, and for every adjournment.

For a copy or extract of any document in the custody of the Central Office, not exceeding 216 words, £1.30, and, if exceeding that number, 33p per folio of 72 words, in addition to the fee, if any, for the signature of the Chief Registrar or Central Office, or for the seal of the Central Office: provided that where a photocopy is supplied the fee charged therefor may be of an amount less than the fee payable on the basis of word content.	
For any document certified as a true copy of a document in the custody of the Central Office where the copy so certified is not made by the Central Office, 65p for the examination of such copy, and if the copy exceeds 216 words, for every additional folio of 72 words, 13p (in addition to the fee for the signature of the Chief Registrar or Central Office, or for the seal of the Central Office).	

3. The Building Societies (Fees) Regulations 1977(a) are hereby revoked.
