The Investment Grants Termination (No. 8) Order 1978

Made - - - - 20th January 1978

Laid before Parliament 30th January 1978

Coming into Operation 20th February 1978

The Secretary of State in exercise of his powers under section 1(6) of the Investment and Building Grants Act 1971(a) and all other powers in that behalf enabling him, hereby orders as follows:—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Investment Grants Termination (No. 8) Order 1978 and shall come into force on 20th February 1978.

(2) The Interpretation Act 1889(b) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

Dates before which certain applications for grant are to be made

2.—(1) Applications for grant under Part I of the Industrial Development Act 1966(c) in respect of expenditure incurred during the period 1st April 1977 to 30th September 1977 (both dates inclusive) are to be made before 1st January 1979.

(2) Such applications in respect of expenditure incurred during the period 1st October 1977 to 31st March 1978 (both dates inclusive) are to be made before 1st April 1979.

(3) Such applications in respect of expenditure incurred during the period 1st April 1978 to 30th September 1978 (both dates inclusive) are to be made before 1st July 1979.

(4) Such applications in respect of expenditure incurred during the period 1st October 1978 to 31st March 1979 (both dates inclusive) are to be made before 1st October 1979.

(5) Such applications in respect of expenditure incurred during the period 1st April 1979 to 31st March 1983 (both dates inclusive) are to be made before the last day of a six months' period beginning with the day on which the expenditure is incurred.

3. The applications for grant to which this Order applies are to be made in such form and manner, and to contain such particulars and be accompanied by such documents, as the Secretary of State may direct.

EXPLANATORY NOTE

(This Note is not part of the Order.)

The Investment Grants Termination (No. 1) Order 1971 (S.I. 1971/1275), the Investment Grants Termination (No. 2) Order 1972 (S.I. 1972/34), the Investment Grants Termination (No. 3) Order 1973 (S.I. 1973/384), the Investment Grants Termination (No. 4) Order 1974 (S.I. 1974/646), the Investment Grants Termination (No. 5) Order 1975 (S.I. 1975/32), the Investment Grants Termination (No. 6) Order 1976 (S.I. 1976/41) and the Investment Grants Termination (No. 7) Order 1977 (S.I. 1977/12) each specified certain dates by which applications for investment grant in respect of expenditure incurred before a related date or in related periods must be made. This Order specifies further dates by which such applications in respect of expenditure in further related periods must be made.

The Order also provides for the making of directions as to the form of such applications, the particulars they must contain and the documents to accompany them.
