**BETTING, GAMING AND LOTTERIES****The Gaming Act (Variation of Monetary Limits)  
(Scotland) Order 1978**

<i>Made</i> - - - -	19th January 1978
<i>Laid before Parliament</i>	27th January 1978
<i>Coming into Operation</i>	20th February 1978

In exercise of the powers conferred on me by sections 34(9) and 51(4) of the Gaming Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

1.—(1) This order may be cited as the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1978 and shall come into operation on 20th February 1978.

(2) This order shall extend to Scotland only.

2. The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

3. The provisions of section 34 of the Gaming Act 1968 specified in the first column of the Schedule to this order (which relate to maximum sums permitted, under the conditions for playing a game by machine for amusement purposes, in respect of the matters mentioned in the second column of that Schedule) shall have effect as if, for the references to the sums specified in those provisions (for which the sums mentioned in the third column of that Schedule were substituted by the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1976(c)), there were substituted references to the sums specified in the fourth column thereof, respectively.

4. In the Schedule to the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1976 the entries relating to section 34 of the Gaming Act 1968 shall be omitted.
