The Brucellosis (Eradication Areas) (Scotland) Amendment (No. 2) Order 1978

In exercise of the powers conferred by sections 1, 5 and 85 (1) of the Diseases of Animals Act 1950(a) and now vested in me(b), as read with the Diseases of Animals (Extension of Definitions) Order 1971(c) and of all other powers enabling me in that behalf, I hereby make the following order:—

Citation and commencement

1. This order may be cited as the Brucellosis (Eradication Areas) (Scotland) Amendment (No. 2) Order 1978 and shall come into operation on 17th July 1978.

Interpretation

2. The Interpretation Act 1889(d) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

Revocation in part of the Brucellosis (Eradication Areas) (Scotland) Order 1973

3. Article 2 of and the Schedule to the Brucellosis (Eradication Areas) (Scotland) Order 1973(e) shall cease to have effect and are hereby revoked in relation to—

- (a) the areas forming part of No. 10 Eradication Area and described in that Schedule as "That part of the county of Perth comprising the parishes of Abernethy, Arngask, Dron and so much of the parishes of Dunbarney and Forteviot as lie south of the River Earn";
- (b) the areas forming part of No. 10 Eradication Area and described in that Schedule as the parishes of Forgandenny, Glendevon, Dunning, Auchterarder, Blackford and so much of the parish of Trinity Gask, as lies south of the River Earn;
- (c) the areas forming part of No. 10 Eradication Area and described in that Schedule as the parishes of Ardoch, Muthill and so much of the parish of Monzievaird and Strowan as lies south of the River Earn;
- (d) the areas forming part of No. 10 Eradication Area and described in that Schedule as so much of the parish of Comrie as lies south of the River Earn and the south bank of Loch Earn;
- (e) the areas forming part of No. 11 Eradication Area and described in that Schedule as the counties of Fife and Kinross.

Revocation in part of the Brucellosis (Eradication Areas) (Scotland) (No. 2) Order 1973

4. Article 3 of and the Schedule to the Brucellosis (Eradication Areas) (Scotland) (No. 2) Order 1973(a) shall cease to have effect and are hereby revoked in relation to—

- (a) the areas forming part of No. 14 Eradication Area and described in that Schedule as the parishes of Aberdalgie, Abernyte, Auchtergaven, Errol, Findo Gask, Inchture, Kilspindie, Kinclaven, Kinfauns, Kinnaird, Kinnoull, Methven, Moneydie, Perth, Redgorton, Rhynd, St. Madoes, Scone, Tibbermore and so much of the parishes of Dunbarney and Forteviot as lie north of the River Earn;
- (b) the areas forming part of No. 14 Eradication Area and described in that Schedule as "The parishes of Crieff, Fowlis Wester, Logiealmond, Madderty, so much of the parishes of Monzievaird and Strowan and of Trinity Gask as lie north of the River Earn";
- (c) so much of the area forming part of No. 14 Eradication Area and described in that Schedule as "so much of the parish of Comrie as lies north of the River Earn and the north bank of Loch Earn" as lies within the District of Perth and Kinross;
- (d) the areas forming part of No. 14 Eradication Area and described in that Schedule as the parishes of Blair Atholl, Dull, Dunkeld and Dowally, Fortingall, Little Dunkeld, Logierait, Moulin and Weem and so much of the area described as "the parish of Kenmore" as lies within the District of Perth and Kinross, and
- (e) the areas forming part of No. 14 Eradication Area and described in that Schedule as "The parishes of Alyth, Bendochy, Blairgowrie, Caputh, Cargill, Clunie, Collace, Coupar Angus, Kinloch, Kirkmichael, Lethendy, Meigle, Rattray and St. Martins".

Revocation in part of the Brucellosis (Eradication Areas) (Scotland) Order 1975

5. Article 3 of and the Schedule to the Brucellosis (Eradication Areas) (Scotland) Order 1975(b) shall cease to have effect and are hereby revoked in relation to so much of the area forming part of No. 20 Eradication Area and described in that Schedule as "The County of Angus including the county of the City of Dundee" as lies within the District of Perth and Kinross.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order revokes the application of the Brucellosis (Eradication Areas) (Scotland) Order 1973, the Brucellosis (Eradication Areas) (Scotland) (No. 2) Order 1973, and the Brucellosis (Eradication Areas) (Scotland) Order 1975 to—

- (i) the former counties of Fife and Kinross,
- (ii) so much of the former county of Angus and Perthshire as falls within the District of Perth and Kinross,

with the consequence that these areas cease to be eradication areas, or to form part of an eradication area as the case may be, on 17th July 1978. By virtue of the Brucellosis (Attested Areas) (Scotland) Extension (No. 2) Order 1978 (S.I. 1978/944) they become part of an attested area on that day.
