ROADS AND BRIDGES, SCOTLAND

The London-Edinburgh-Thurso Trunk Road (Tain Bypass Trunking and Detrunking) Order 1979

Made - - - 31st August 1979 Coming into Operation 28th September 1979

The Secretary of State in exercise of the powers conferred on him by section 1(2) of the Trunk Roads Act, 1946(a) and of all other powers enabling him in that behalf, and having complied with the provisions of Schedule 2 of the said Act of 1946(b) hereby makes the following order:—

1. This order may be cited as the London-Edinburgh-Thurso Trunk Road (Tain Bypass Trunking and Detrunking) Order 1979 and shall come into operation on 28th September 1979.

2. On the date of the coming into operation of this order the road described in Schedule 1 to this order hereinafter referred to as the "new road" shall become a trunk road and the road described in Schedule 2 to this order shall cease to be a trunk road.

SCHEDULE 1

LENGTH OF ROAD TO BECOME TRUNK ROAD

That length of new road extending from a point on the London-Edinburgh-Thurso Trunk Road (A9) 158 metres or thereby south-east of the south-east gable of Morangie Cottages near Tain in Highland Region in a generally southerly then easterly then south-easterly direction for a distance of 3.06 kilometres or thereby to a point on the said trunk road 290 metres or thereby south-east of the junction with the access to Knockbreck Farm near Tain, as shown by a heavy black line between the points marked 'A' and 'C' on the plan numbered R/TO/1/RC/128 and marked "The London-Edinburgh-Thurso Trunk Road (Tain Bypass Trunking and Detrunking) Order 1979'' signed and sealed with reference to this order and deposited at the office of the Scottish Development Department, New St. Andrew's House, Edinburgh. A certified copy of the said plan has been deposited at the office of the Regional Council of the Highland Region, Regional Buildings, Glenurquhart Road, Inverness.

SCHEDULE 2

LENGTH OF ROAD CEASING TO BE TRUNK ROAD

That length of the London-Edinburgh-Thurso Trunk Road (A9) extending from a point on the said trunk road 341 metres or thereby south-east of the south corner of Morangie Cottages near Tain in Highland Region in a generally south-easterly direction for a distance of 2.65 kilometres or thereby to a point on the said trunk road 290 metres or thereby south-east of the junction with the access to Knockbreck Farm on the said trunk road near Tain as shown by black and white hatching between the points marked 'B' and 'C' on the said plan.
