**The Local Land Charges (Amendment) Rules 1979**

The Lord Chancellor, in exercise of the powers conferred on him by section 14 of the Local Land Charges Act 1975(a) and with the concurrence of the Treasury as to fees, hereby makes the following Rules:—

1. These Rules may be cited as the Local Land Charges (Amendment) Rules 1979 and shall come into operation on 3rd December 1979.

2. For Schedule 3 to the Local Land Charges Rules 1977(b) there shall be substituted the following Schedule:—
