## LEGAL AID AND ADVICE, SCOTLAND

## Act of Adjournal (Criminal Legal Aid Fees Amendment) 1979

Made - - - - 6th December 1979

Coming into Operation 7th January 1980

The Lord Justice General, Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred upon them by section 16 of the Legal Aid (Scotland) Act 1967(a) and sections 282 and 457 of the Criminal Procedure (Scotland) Act 1975(b), and of all other powers competent to them in that behalf, do hereby enact and declare:

*Citation, commencement and revocation*

1.—(1) This Act of Adjournal may be cited as the Act of Adjournal (Criminal Legal Aid Fees Amendment) 1979 and shall come into operation on 7th January 1980.

(2) The Act of Adjournal (Criminal Legal Aid Fees Amendment) 1978(c) is revoked.

*New fees*

2. In the Act of Adjournal (Criminal Legal Aid Fees) 1964(d), in the sections of that Act specified in column 1 of the Schedule to this Act of Adjournal, for the figures specified opposite those sections in column 2 of the Schedule, there are substituted the figures specified opposite those figures in column 3 of the Schedule; and the figures so substituted, shall be the minimum fees or the maximum fees, as the case may be, payable under those sections on and after the date on which this Act of Adjournal comes into operation, whether or not the proceedings in respect of which they are so payable are pending on that date, or are commenced thereafter.

And the Lords appoint this Act of Adjournal to be recorded in the Books of Adjournal.
