**The Pensions Appeal Tribunals (England and Wales)
 (Amendment) Rules 1979**

Made - - - - 20th December 1979

Laid before Parliament 7th January 1980

Coming into Operation 29th January 1980

The Lord Chancellor, in exercise of the powers conferred on him by paragraph 5 of the Schedule to the Pensions Appeal Tribunals Act 1943(a) as amended by the Administration of Justice Act 1977(b), and after consultation with the Council on Tribunals in accordance with Section 10 of the Tribunals and Inquiries Act 1971(c), hereby makes the following Rules:—

1. These Rules may be cited as the Pensions Appeal Tribunals (England and Wales) (Amendment) Rules 1979 and shall come into operation on 29th January 1980.

2. The Pensions Appeal Tribunals (England and Wales) Rules 1971(d) shall be further amended as follows:—

- (1) In rule 27(2) (which relates to expenses for loss of time), for the figure “£10.75” there shall be substituted the figure “£14.00”; and for the figure “£5.38” there shall be substituted the figure “£7.00”.
- (2) In rule 30 (which relates to the expenses of medical and other experts)—
 - (a) For the figure “£43.50” wherever it appears there shall be substituted the figure “£54.80”.
 - (b) in paragraph (2) for the figure “£21.80” there shall be substituted the figure “£27.50”.
 - (c) in paragraph (3) for the figure “£1.50” there shall be substituted the figure “£2.00”.
- (3) In Schedule 2 Part I (which relates to subsistence allowances to appellants and witnesses) in paragraph 1(a) for the figures “£0.53”, “£1.05” and “£2.50” there shall be substituted the figures “£0.63”, “£1.25” and “£3.00” respectively, in paragraph 1(b)(i) for the figure “£14.80” there shall be substituted the figure “£17.80” and in paragraph 1(b)(ii) for the figure “£13.25” there shall be substituted the figure “£15.90”.

- (4) In Schedule 2 Part II (which relates to expenses of medical evidence) in paragraph 1(a) for the figures “£21.80” and “£43.50” there shall be substituted the figures “£27.50” and “£54.80” respectively and in paragraph 2, for the figure “£43.50” there shall be substituted the figure “£54.80”.
