**The Charities (Arundell Street Fund, The City of Westminster)  
Order 1979**

*Laid before Parliament in draft*

*Made - - - 7th March 1979*

*Coming into Operation 21st March 1979*

Whereas the Charity Commissioners for England and Wales have, in pursuance of subsection (1) of section 19 of the Charities Act 1960(a), settled the Scheme set out in the Appendix to this Order with a view to its being given effect under that section:

And Whereas the said Scheme does not alter any statutory provision contained in or having effect under any public general Act of Parliament:

Now, therefore, in pursuance of section 19(2) of the Charities Act 1960, I hereby make the following Order:—

1. This Order may be cited as the Charities (Arundell Street Fund, The City of Westminster) Order 1979 and shall come into operation on the fourteenth day after the day on which it is made.

2. The Scheme set out in the Appendix to this Order shall have effect.

## APPENDIX

### SCHEME FOR THE ADMINISTRATION OF THE CHARITY KNOWN AS THE ARUNDELL STREET FUND IN THE CITY OF WESTMINSTER

Whereas the Charity known as the Arundell Street Fund in The City of Westminster is now regulated by the Arundell Estate (Closing of Arundell Street and Panton Square) Act 1913(a):

And Whereas application has been made to the Charity Commissioners by the body corporate called the Lord Mayor, Aldermen and Citizens of The City of Westminster, the Trustees of the Charity, for a Scheme for the administration of the Charity:

And Whereas it appears to the Charity Commissioners that a Scheme should be established for the administration of the Charity but that it is necessary for the Scheme to alter the provision made by the said Act of 1913:

And Whereas in pursuance of section 21 of the Charities Act 1960 public notice of the Charity Commissioners' proposals for this Scheme has been given and no representations have been received by the Charity Commissioners in respect thereof:

Now, therefore, the Charity Commissioners for England and Wales, in pursuance of section 19(1) of the Charities Act 1960, hereby settle the following Scheme:—

### SCHEME

1. *Administration of Charity.*—The above-mentioned Charity and the property thereof specified in the schedule hereto and all other the property (if any) of the Charity shall be administered and managed subject to and in conformity with the provisions of this Scheme by the body corporate called the Lord Mayor, Aldermen and Citizens of The City of Westminster, the Trustees of the Charity.

2. *Application of income.*—The Trustees shall apply the clear income of the Charity for all or any of the following purposes:—

- (1) The relief of the aged, impotent and poor inhabitants of The City of Westminster (the inhabitants of the said city being hereinafter referred to as "the said inhabitants");
- (2) The relief of distress and sickness among the said inhabitants;
- (3) The provision and support (with the object of improving the conditions of life for the said inhabitants in the interests of social welfare) of facilities for recreation or other leisure-time occupation;
- (4) The provision and support of educational facilities for the said inhabitants;
- (5) Any other charitable purposes (whether or not of a nature similar to any of those hereinbefore specified) for the benefit of the said inhabitants:

Provided always that such purposes shall extend to those purposes for which provision is made out of rates, taxes or other public funds, only if and to the extent to which in the opinion of the Trustees further provision (in addition to that made out of rates, taxes or other public funds) can properly be made for such purposes.

3. *Questions of construction.*—Any question as to the construction of this Scheme may be referred to the Charity Commissioners for their opinion or advice in accordance with the provisions of section 24 of the Charities Act 1960.

## SCHEDULE

The following investments standing in the name of The Lord Mayor, Aldermen and citizens of The City of Westminster:

£19,518 3¼% War Loan representing permanent endowment.

£93,000 10¼% Treasury Stock 1979 representing accumulations of income.

£14,953.26 3¼% War Loan representing accumulations of income.

£100 cash on current account at the Westminster City Hall branch of National Westminster Bank Limited.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order gives effect to a Scheme of the Charity Commissioners relating to a charity consisting of a fund for the widening of Whitcomb Street, Wardour Street or Argyll Place in The City of Westminster which has never been used and is no longer required.

The Scheme provides for the application of the income of the charity for the benefit of the inhabitants of the said city.
