The Customs Duties (ECSC) Provisional Anti-Dumping (Revocation) (No. 2) Order 1979

Made - - - - - - - 30th April 1979

Coming into Operation - - - - 3rd May 1979

The Secretary of State, in exercise of the powers conferred on him by section 6(1) and (2) of the Finance Act 1978(a) and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation, operation, interpretation

- 1.—(1) This Order may be cited as the Customs Duties (ECSC) Provisional Anti-Dumping (Revocation) (No. 2) Order 1979 and shall come into operation on 3rd May 1979.
- (2) In this Order "the principal Orders" means the Customs Duties (ECSC) Provisional Anti-Dumping Order 1979(b) and the Customs Duties (ECSC) Provisional Anti-Dumping (No. 3) Order 1979(c).
- (3) This Order is made pursuant to Commission Recommendation 787/79/ECSC(d) requiring the cancellation of the duties imposed by the principal Orders in relation to imports of goods originating in, and consigned from, Spain.

Revocation

- 2.—(1) The principal Orders are hereby revoked in so far as they relate to goods originating in, and consigned from, Spain imported into the United Kingdom on or after 11th April 1979.
- (2) Nothing in paragraph (1) above affects the continued operation of the principal Orders with respect to goods originating in Spain and consigned to the United Kingdom from another country.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order revokes the Customs Duties (ECSC) Provisional Anti-Dumping Order 1979 and the Customs Duties (ECSC) Provisional Anti-Dumping (No. 3) Order 1979 in relation to imports into the United Kingdom on or after 11th April 1979 of certain angles, shapes and sections and certain sheets and plates of iron and steel originating in and consigned from Spain. Duty imposed by those Orders on imports of these goods originating in Spain but consigned from other countries continues to be charged.

The duty charged by those Orders on those imports before the coming into operation of this Order was not collectable if the importer gave security of the amount of the duty to the Commissioners of Customs and Excise in accordance with the provisions of the Anti-Dumping and Countervailing Duties Order 1978 (S.I. 1978/1147), and that security will be released without collection of any duty in respect of goods originating in and consigned from Spain.

The United Kingdom is under a Community obligation by virtue of the Recommendation referred to in the Order to cancel the duty in respect of imports into the United Kingdom on or after 11th April 1979.
