WATER SUPPLY, SCOTLAND

**The Tayside Regional Council (Allt Mhor, Kinloch Rannoch)
(Amendment) Water Order 1979**

Made - - - - - 31st July 1979

Coming into Operation 7th August 1979

The Secretary of State in exercise of the powers conferred on him by sections 21(2) and 44(1) of the Water (Scotland) Act 1946(a) as read with section 148 of, and paragraph 1 of Schedule 17 to the Local Government (Scotland) Act 1973(b) and by section 75 of the Water (Scotland) Act 1946, and of all other powers enabling him in that behalf, on the application of the Tayside Regional Council, hereby makes the following order:—

Citation and commencement

1.—(1) This order may be cited as The Tayside Regional Council (Allt Mhor, Kinloch Rannoch) (Amendment) Water Order 1979 and shall come into operation on 7th August 1979.

(2) This order and the Perth County Council (Allt Mhor, Kinloch Rannoch) Water Order 1950(c) (hereinafter referred to as “the Principal Order”) shall be construed as one and may be cited together as The Tayside Regional Council (Allt Mhor, Kinloch Rannoch) Water Orders 1950 and 1979.

Amendment of the Principal Order

2. In article 4 of the Principal Order for the word “stream” substitute “streams”.

3.—(1) In article 5(2) of the Principal Order for the words “twenty-five” and the figures “1,042” substitute “forty” and “1,667” respectively.

(2) After article 5(2) of the Principal Order there shall be inserted the following paragraph:—

“(3) The Council shall not take from the said Allt Mhor such a quantity of water as will at any time reduce the flow of water therein to a rate of flow of less than twenty-five thousand gallons per day measured over an approved gauge forming part of the dam referred to in Article 4 hereof and shown on the plan and sections marked “The Tayside Regional Council (Allt Mhor,
