LAND DRAINAGE

The Severn-Trent Water Authority (Alteration of Boundaries of the Newark Area Internal Drainage District) Order 1980

Made - - - - - 22nd May 1980

Coming into Operation 1st August 1980

Whereas the Severn-Trent Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976^(a) in relation to the Newark Area Internal Drainage District;

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of every other power enabling him in that behalf, hereby orders as follows:-

1. This Order, which may be cited as the Severn-Trent Water Authority (Alteration of Boundaries of the Newark Area Internal Drainage District) Order 1980, shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Severn-Trent Water Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1976
SEVERN-TRENT WATER AUTHORITY
NEWARK AREA INTERNAL DRAINAGE DISTRICT

Whereas the Scheme set out below has been prepared by the Severn-Trent Water Authority (hereinafter called "the Water Authority") in pursuance of section 11(1) of the Land Drainage Act 1976, for the alteration of the boundaries of the Newark Area Internal Drainage District (hereinafter called "the Drainage District");

Now, therefore, the Water Authority submit the Scheme to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation under section 11(4) of the said Act of 1976.

SCHEME

On a day to be appointed by the Minister (which day is hereinafter called "the appointed day") the boundaries of the Drainage District as constituted by the Scheme confirmed by the River Trent Catchment Board (Newark Area Internal Drainage District) Order 1949(a) and altered by the Scheme confirmed by the Severn-Trent and the Anglian Water Authorities (Newark Area and Upper Witham Internal Drainage Districts) Order 1974(b) shall be further altered so as to include within the Drainage District all those lands shown coloured red on the map sealed by the Water Authority in relation to this Scheme.

IN WITNESS whereof the Severn-Trent Water Authority have caused their Common Seal to be hereunto affixed this thirty-first day of October One Thousand nine hundred and seventy-nine.
