WATER, ENGLAND AND WALES

The Thames Water Authority (Langley Vale) Order 1980

Made - - - 1st February 1980

Coming into Operation 11th February 1980

The Secretary of State for the Environment, in exercise of powers conferred by section 23 of the Water Act 1945(a) and now vested in him(b) and of all other powers enabling him in that behalf, hereby orders as follows:—

1.—(1) This order may be cited as the Thames Water Authority (Langley Vale) Order 1980 and shall come into operation on 11th February 1980. Citation and commencement.

(2) The Thames Water Authority Orders 1974 to 1979 and this order may be cited together as the Thames Water Authority Orders 1974 to 1980.

2. In this order, unless the context otherwise requires— Interpretation.

“the Authority” means the Thames Water Authority;

“the borehole” means the borehole 24 inches in diameter constructed on and under the land described in Schedule 1 to this order;

“the Third Schedule” means the Third Schedule to the Water Act 1945;

“the undertaking” means the water undertaking of the Authority as for the time being authorised by any enactment.

3.—The Authority may, when they have obtained sufficient rights or interest in the land described in Schedule 1 to this order, continue and maintain the borehole and (in addition to the works authorised by section 4 of the Third Schedule as applied to the undertaking by this order) may construct and maintain on the said land all such additional wells, boreholes, adits and headings as may be necessary or expedient for augmenting, improving or maintaining the supply of water obtainable by means of the said borehole. Authorisation of works.

4. The borehole and any other works constructed in pursuance of this order shall for all purposes form part of the undertaking. Works to form part of the undertaking.

5. For the purposes of this order the provisions of the Third Schedule which are specified in column (1) of Schedule 2 to this order shall, subject to the modifications set out in column (2) thereof, apply to the undertaking and are hereby incorporated with this order. Application of provisions of Third Schedule.

SCHEDULE 1

DESCRIPTION OF LAND

Land in the Parish of Epsom in the Borough of Epsom and Ewell in the County of Surrey comprising 240 square metres or thereabouts and being part of the enclosure numbered 5654 on the 1/2500 Ordnance Survey plans of Surrey Sheet TQ 2057 Edition of 1954.

SCHEDULE 2

PROVISIONS OF THE THIRD SCHEDULE APPLIED

Provisions applied (1)	Modifications (2)
Section 4 (General power to construct subsidiary works)	The words "and to any other provisions of the special Act limiting the powers of the undertakers to abstract water" shall be omitted, and for the words "any land for the time being held by them in connection with their water undertaking" there shall be substituted the words "any of the land described in the special Act".
Section 94 (Copies of the special Act to be kept by undertakers in their office, and deposited with certain officers)	In sub-section (1) for the words from "with the clerk of the council" to the end of the sub-section, there shall be substituted the words "with the council of every county and district affected by the special Act".
