The Appointment of Ports (Weymouth, Poole, Solent, Littlehampton, Shoreham and Newhaven) Order 1980

Made - - -

8th September 1980

Coming into Operation

1st October 1980

The Commissioners of Customs and Excise, in pursuance of the powers conferred on them by section 19 of the Customs and Excise Management Act 1979(a) and of all other powers enabling them in that behalf, hereby make the following Order:—

Citation and Commencement

1. This Order may be cited as the Appointment of Ports (Weymouth, Poole, Solent, Littlehampton, Shoreham and Newhaven) Order 1980 and shall come into operation on 1st October 1980.

Interpretation

2. In this Order, "approaches" in relation to a dock or harbour means all waters leading thereto from the areas specified in the appointments contained in this Order.

Revocation of Earlier Appointments

3. The Treasury Warrants set out in the Schedule hereto are hereby revoked

Port of Weymouth

- **4.**—(1) The Commissioners appoint as a port for the purposes of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from the western bank of the River Char at latitude 50° 43′ 56.8″ north, longitude 02° 53′ 58.5″ west (a limit of the Port of Exeter);
 - (b) to the east by a line on a true bearing 180° from St. Alban's Head at latitude 50° 34′ 33.1″ north, longitude 02° 03′ 14.2″ west (a limit of the Port of Poole);
 - (c) by mean high water line along the coast between the points described in (a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Weymouth.

Port of Poole

- 5.—(1) The Commissioners appoint as a port for the purposes of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from St. Alban's Head at latitude 50° 34′ 33.1″ north, longitude 02° 03′ 14.2″ west (a limit of the Port of Weymouth);
 - (b) to the east by a line on a true bearing 180° from Hengistbury Head at latitude 50° 42′ 44.3″ north, longitude 01° 44′ 51″ west (a limit of the Port of Solent);
 - (c) by mean high water line along the coast between the points described in(a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Poole.

Port of Solent

- **6.**—(1) The Commissioners appoint as a port for the purposes of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from Hengistbury Head at latitude 50° 42′ 44.3″ north, longitude 01° 44′ 51″ west (a limit of the Port of Poole);
 - (b) to the east by a line on a true bearing 180° from Selsey Bill at latitude 50° 43′ 18.5″ north, longitude 00° 47′ 07.3″ west (a limit of the Port of Littlehampton);
 - (c) by mean high water line along the coast between the points described in (a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Solent.

Port of Littlehampton

- 7.—(1) The Commissioners appoint as a port for the purposes of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from Selsey Bill at latitude 50° 43′ 18.5″ north, longitude 00° 47′ 07.3″ west (a limit of the Port of Solent):
 - (b) to the east by a line on a true bearing 180° from a point on the coast near Ferring at latitude 50° 48′ 09.7" north, longitude 00° 26′ 04.3" west (a limit of the Port of Shoreham);
 - (c) by mean high water line along the coast between the points described in (a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Littlehampton.

Port of Shoreham

- **8.**—(1) The Commissioners appoint as a port for the purposes of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from a point on the coast near Ferring at latitude 50° 48′ 09.7" north, longitude 00° 26′ 04.3" west (a limit of the Port of Littlehampton);
 - (b) to the east by a line on a true bearing 180° from a point on the coast near Rottingdean at latitude 50° 47′ 55.2″ north, longitude 00° 02′ 14.2″ west (a limit of the Port of Newhaven);
 - (c) by mean high water line along the coast between the points described in (a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Shoreham.

Port of Newhaven

- 9.—(1) The Commissioners appoint as a port for the purpose of customs and excise those internal and territorial waters of Her Majesty's dominions within the area bounded:—
 - (a) to the west by a line on a true bearing 180° from a point on the coast near Rottingdean at latitude 50° 47′ 55.2″ north, longitude 00° 02′ 14.2″ west (a limit of the Port of Shoreham);
 - (b) to the east by a line on a true bearing 180° from Galley Hill at latitude 50° 50′ 25.4″ north, longitude 00° 29′ 57.6″ east (a limit of the Port of Folkestone);
 - (c) by mean high water line along the coast between the points described in (a) and (b) above; and
 - (d) by the seaward limit of territorial waters between the limits described in (a) and (b) above,

together with-

- (i) docks and harbours, including the approaches thereto, and
- (ii) as far as the tide flows, all rivers, canals, bays, creeks, streams, channels, waters and watercourses

giving on to the area specified in this Article.

(2) The Commissioners name the said port the Port of Newhaven.
