## The Diseases of Animals

## (Fees for the Testing of Disinfectants) Order 1980

Made - - - - 11th September 1980

Laid before the  
House of Commons 19th September 1980

Coming into Operation 10th October 1980

The Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland and the Secretary of State for Wales, acting jointly, in exercise of the powers conferred by section 16(1) and (5) of the Agriculture (Miscellaneous Provisions) Act 1963(a), and now vested in them(b), and of all other powers enabling them in that behalf, with the approval of the Treasury, hereby order as follows:—

*Citation, extent, commencement and interpretation*

1.—(1) This order, which may be cited as the Diseases of Animals (Fees for the Testing of Disinfectants) Order 1980, shall apply to Great Britain and shall come into operation on 10th October 1980.

(2) In this order “the Order of 1978” means the Diseases of Animals (Approved Disinfectants) Order 1978(c).

*Fees for the testing of disinfectants*

2. There shall be payable to the Minister of Agriculture, Fisheries and Food in respect of the testing, in pursuance of Article 7(1) of the Order of 1978, of any disinfectant submitted for the purpose of having such disinfectant listed as approved in the Schedule to that order the fees set out in the Schedule to this order.

*Revocation*

3. The Diseases of Animals (Fees for the Testing of Disinfectants) Order 1979(d) is hereby revoked.

4. For each testing of a disinfectant for efficacy against Fowl Pest—	
(a) in the case of a single dilution test .....	£178-00
(b) in the case of a multiple dilution test .....	£234-00
5. For each testing of a disinfectant for efficacy against Tuberculosis ..	£122-00
6. For each testing of a disinfectant for efficacy against a disease of animals other than those mentioned in paragraphs 2 to 5 above .....	£122-00
7. For administrative services in respect of each submission for testing of a disinfectant (whether for one, or for more than one, test) .....	£51-00
