

**1980 No.1554 (S.124)****COURT OF SESSION, SCOTLAND****Act of Sederunt (Fees of Messengers-at-Arms) 1980**

*Made* - - - - - 14th October 1980

*Coming into operation* 17th November 1980

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 6 of the Execution of Diligence (Scotland) Act 1926(a) and section 16 of the Administration of Justice (Scotland) Act 1933(b), and of all other powers competent to them in that behalf, do hereby, with the concurrence of the Lord Lyon King of Arms, enact and declare:—

*Citation and commencement*

1.(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Messengers-at-Arms) 1980 and shall come into operation on 17th November 1980.

(2) This Act of Sederunt shall be inserted in the Books of Sederunt.

*Amendment of Fees*

2. In the Schedule to the Act of Sederunt (Fees of Messengers-at-Arms) 1978(c), in the paragraphs specified in column 1 of the following table, for the fees specified in column 2 substitute the fees specified in column 3 of the table, and the fees so substituted shall be payable in respect of work done on or after the date on which this Act of Sederunt comes into operation.
