HOUSING, SCOTLAND

The Housing Support Grant (Scotland) Variation Order 1981

Laid before the Commons House of Parliament in draft
Made - - - 22nd January 1981
Coming into operation in accordance with article 1(1)

In exercise of the powers conferred on me by sections 1, 2 and 3 of the Housing (Financial Provisions) (Scotland) Act 1978(a), and of all other powers enabling me in that behalf, since it appears to me that after the time when the amount mentioned in section 1(2)(a) of the said Act was re-estimated for 1979-80 the eligible expenditure of local authorities for that year has been substantially increased by reason of changes which have taken place in the level of the matters specified in section 1(3)(b) of the said Act, and that inadequate account was taken of those changes when the amount mentioned as aforesaid was re-estimated, with the consent of the Treasury and after consulting with such associations of local authorities as appear to me to be concerned, I hereby make the following order, a draft of which has been approved by the Commons House of Parliament:—

Title, commencement and interpretation

- 1.—(1) This order may be cited as the Housing Support Grant (Scotland) Variation Order 1981 and shall come into operation forthwith.
 - (2) In this order—

"the 1978 Act" means the Housing (Financial Provisions) (Scotland) Act 1978;

"the Variation Order of 1980" means the Housing Support Grant (Scotland) Variation Order 1980(b).

Aggregate grant for 1979-80

2. For the aggregate amount of housing support grant and the transitional and hostel portions thereof fixed for the year 1979-80 by article 2 of the Variation Order of 1980 as indicated in parentheses in the second column of the following table there shall be substituted the amount and portions set out in the third column thereof:—
