**The Social Security Benefits Up-rating Order 1981**

*Laid before Parliament in draft*

*Made - - - - - 12th August 1981*

*Coming into Operation    23rd November 1981*

Whereas, the Secretary of State for Social Services having made reviews, and statements having been made in each House of Parliament, under sections 125 and 126A of the Social Security Act 1975 (a), and the Secretary of State for Social Services having considered under section 37A (4) of that Act whether the rate of mobility allowance should be increased, a draft of the following order was laid before Parliament in accordance with the provisions of sections 125(3)(b) and 126A(2)(b) of that Act and approved by resolution of each House of Parliament:

Now, therefore, the Secretary of State for Social Services, in conjunction with the Treasury (b), in exercise of the powers conferred upon him by sections 124 and 126A of the above-mentioned Act (c) and section 23(1) of the Social Security Pensions Act 1975 (d), and of all other powers enabling him in that behalf, hereby makes the following order:—

*Citation, commencement and interpretation*

1.—(1) This order may be cited as the Social Security Benefits Up-rating Order 1981 and shall come into operation on 23rd November 1981.

(2) In this order, unless the context otherwise requires—

“ the Act ” means the Social Security Act 1975, and

“ the Pensions Act ” means the Social Security Pensions Act 1975.

*Alteration in rates or amounts of certain benefits under the Act*

2.—(1) In this Article, “ Schedule 4 ” means Schedule 4 to the Act (a).

(2) The sums specified in paragraph (3) below shall be altered from and including the respective dates specified in Article 4 below; and Schedule 4 shall accordingly have effect as set out in the Schedule to this order.

(3) The sums mentioned in paragraph (2) above are the sums specified in Parts I, III, IV and V of Schedule 4 (contributory periodical benefits, non-contributory periodical benefits, increases of benefits for dependants and rate or amount of industrial injuries benefits, respectively), except the sum specified in the said Part III for age addition.

*Increase of rates or amounts of certain benefits under the Pensions Act*

3.—(1) The sums mentioned in paragraphs (2) to (5) below shall be increased from and including the respective dates specified in Article 4 below.

(2) In section 6(1)(a) of the Pensions Act (basic component of Category A retirement pension)—

(a) so far as the sum is relevant for the purpose of calculating under section 14(6) of the Act the rate of unemployment or sickness benefit and of calculating under section 15(4) of the Act or section 14, 15 or 16 of the Pensions Act the rate of an invalidity pension, for the sum of £26.00 (b) there shall be substituted the sum of £28.35; and

(b) except so far as mentioned in sub-paragraph (a) above, for the sum of £27.15 (b) there shall be substituted the sum of £29.60.

(3) It is hereby directed that the sums which are the additional components in the rates of long-term benefits calculated by reference to any final relevant year earlier than the tax year 1981/1982 shall be increased by 9.06 per cent. of their amount apart from this order.

(4) It is hereby directed that the sums payable by way of increases of retirement pensions under Schedule 1 to the Pensions Act (increase of pension where pensioner defers retirement) shall be increased by 9.06 per cent.

(5) It is hereby directed that an amount equal to 9.06 per cent. of—

(a) the aggregate amount of the sums payable to a person by virtue of section 35(6) of the Pensions Act (which provides for increases in a person's guaranteed minimum pension if payment of his occupational pension is postponed after he attains pensionable age), including such sums which are payable by virtue of section 36(3) of that Act; and

(b) the amount by which that person's Category A or Category B retirement pension has been increased under section 126A of the Act by virtue of sub-section (1)(b) of that section (up-rating of increments in guaranteed minimum pensions),

but excluding, in either case, any increases under Schedule 1 to the Pensions Act which are increased by paragraph (4) above, shall be payable by way of an increase of his Category A or Category B retirement pension.

*Dates on which sums specified for rates or amounts of benefit under the Act or the Pensions Act are altered by this order*

4.—(1) Subject to paragraph (8) of this Article, the alterations made by this order in the sums specified for rates or amounts of benefit under the Act or the Pensions Act shall take effect for each case on the date specified in relation to such case in the following provisions of this Article.

(2) In relation to the case of a person over pensionable age who has not retired from regular employment and for whom the rate of unemployment benefit, sickness benefit or invalidity pension falls to be calculated in accordance with section 14(6) or 15(4) of the Act, the increases in the sums mentioned in Articles 2, 3 and 6 for Category A and B retirement pension and graduated retirement benefit (together with, where appropriate, increases for dependants) shall take effect on 26th November 1981 and in relation to all other cases the increases in such sums shall take effect on 23rd November 1981.

(3) The increase mentioned in Article 3(5) shall take effect on 23rd November 1981.

(4) The alterations in the amounts of maternity allowance, widow's allowance, widowed mother's allowance, widow's pension, Category C and D retirement pension, child's special allowance, attendance allowance, invalid care allowance (except in a case where the Secretary of State has made arrangements for it to be paid on a Wednesday), guardian's allowance and industrial death benefit by way of widow's and widower's pension and allowance in respect of children (together with, where appropriate, increases for dependants) shall in all cases take effect on 23rd November 1981.

(5) The sums specified for the rate of mobility allowance, invalid care allowance (in a case where the Secretary of State has made arrangements for it to be paid on a Wednesday), disablement benefit (together with increases of disablement pension), maximum disablement gratuity under section 57(5) of the Act, increase of unemployability supplement under section 59 of the Act and maximum, under section 91(1) of the Act, of aggregate of weekly benefit payable for successive accidents, shall be increased in all cases with effect from 25th November 1981.

(6) In relation to the case of a person whose weekly rate of Category A or B retirement pension falls to be increased under the provisions of section 28(7) or 29(8) of the Act by reference to the weekly rate of invalidity allowance to which he was previously entitled, the increase in the sum specified for the appropriate rate of invalidity allowance shall take effect on 23rd November 1981 and in relation to all other cases the increase in such sum shall take effect on 26th November 1981.

(7) The alterations in the rates or amounts of unemployment and sickness benefit, invalidity pension, non-contributory invalidity pension and injury benefit (together with, where appropriate, increases for dependants), shall take effect in all cases on 26th November 1981.

(8) In the case of a person to whom injury benefit under the Act is payable for 25th November 1981 at a reduced weekly rate by virtue of the provisions of section 91(1) of the Act (maximum aggregate of weekly benefit payable for successive accidents), the rate of that benefit or of any sickness benefit or invalidity pension under the Act or the Pensions Act shall be determined as if the alteration in the rates of those benefits took effect on 25th November 1981 and, where appropriate, as if the reference to 26th November 1981 in paragraph (2) of this Article were a reference to 25th November 1981.

*Increase in rates of certain benefits under the Industrial Injuries and Diseases (Old Cases) Act 1975*

5. In the Industrial Injuries and Diseases (Old Cases) Act 1975 (a) the sum of £16·30 referred to in section 2(6)(c) (maximum weekly rate of lesser incapacity allowance supplementing workmen's compensation) and section 7(2)(b) (industrial diseases benefit schemes: weekly rate of allowance payable where disablement is not total) shall be further increased; and from and including 25th November 1981 the reference to that sum in section 2(6)(c), and from and including 26th November 1981 the reference to that sum in section 7(2)(b), shall accordingly have effect as references to £17·75.

*Increase in rate of graduated retirement benefit and increments thereof*

6.—(1) In the National Insurance Act 1965 (b) the sum of 3·54 pence referred to in section 36(1) (graduated retirement benefit) shall be increased by 9·06 per cent.; and from and including 23rd November 1981 the reference in that provision to that sum shall accordingly have effect as a reference to 3·86 pence.

(2) It is hereby directed that the aggregate amount of any increases of graduated retirement benefit payable under Schedule 2 to the Social Security (Graduated Retirement Benefit) (No. 2) Regulations 1978(c) (increases for deferred retirement) shall be increased by 9·06 per cent.

*Revocations*

7. The Social Security Benefits Up-rating Order 1980 (d) is hereby revoked.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order, a draft of which has been laid before and approved by a resolution of each House of Parliament, is made consequent upon reviews under sections 125 and 126A of the Social Security Act 1975. It alters with effect from specified dates in the week beginning 23rd November 1981 the rates and amounts of the benefits and increases of benefit (except age addition) specified in Parts I, III, IV and V of Schedule 4 to that Act; the rates and amounts of certain benefits under Part II of the Social Security Pensions Act 1975 (including increases of Category A or B retirement pension payable by reference to the increases of increments in guaranteed minimum pensions payable by virtue of section 35(6) of that Act); and the rate of graduated retirement benefit under the National Insurance Act 1965. The Order also increases the rates laid down in the Industrial Injuries and Diseases (Old Cases) Act 1975 for the maximum weekly rate of lesser incapacity allowance supplementing workmen's compensation and the weekly rate of allowance under the Industrial Diseases Benefit Schemes where disablement is not total.

In accordance with section 124(3) of the Social Security Act 1975, a copy of a report by the Government Actuary (Cmnd. 8296) giving his opinion on the likely effect on the National Insurance Fund of the making of this Order was laid before Parliament with the draft Order.
