In exercise of the powers conferred on me by section 15 of the Local Government (Scotland) Act 1975(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

Citation and commencement

1. This order may be cited as the Local Authority Grants (Termination) (Scotland) Order 1980 and shall come into operation on 1st April 1981.

Interpretation

2. In this order—

- (a) “local authority” means a regional, islands or district council;
- (b) “local authority grant provision” means an enactment providing for the payment of grants to local authorities in respect of expenditure incurred in connection with a specific function; and
- (c) “year” means the financial year of a local authority.

Termination of grants

3. Subject to article 5 below, no grant shall be paid with effect from the commencement of the year 1981–82 under the local authority grant provisions specified in Schedules 1 and 2 to this order.

Repeals and revocation

4.—(1) The local authority grant provisions specified in Schedule 1 to this order are hereby repealed to the extent specified in that Schedule.

(2) The local authority grant provisions specified in Schedule 2 to this order are hereby revoked to the extent specified in that Schedule.

Saving

5. Nothing in this order shall affect the payment of grant in respect of expenditure incurred prior to the commencement of the year 1981–82.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order terminates, with effect from 1st April 1981, the payment of certain specific grants payable to local authorities in respect of expenditure incurred in the acquisition of land for use as a public open space, the inspection of imported food, the provision of flood warning systems, and the removal of air raid shelters or other temporary defence works from educational sites. The order repeals and revokes the enactments under which those grants were payable but enables grant to be paid in any case where the expenditure was incurred prior to 1st April 1981.
