**AGRICULTURAL GRANTS, GOODS AND SERVICES**

**The Farm Structure (Payments to Outgoers) (Variation)  
Scheme 1981**

*Laid before Parliament in draft*

*Made - - - - 27th November 1981*

*Coming into Operation 30th November 1981*

The Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland and the Secretary of State for Wales, acting jointly, in exercise of the powers conferred on them by sections 27(1) (d) and 35 of the Agriculture Act 1967(a) and now vested in them jointly(b) and in exercise of all other powers enabling them in that behalf with the approval of the Treasury hereby make the following scheme, a draft whereof has been laid before Parliament and approved by a resolution of each House of Parliament:—

*Citation, extent and commencement*

1. This scheme, which may be cited as the Farm Structure (Payments to Outgoers) (Variation) Scheme 1981, shall apply throughout the United Kingdom and shall come into operation on 30th November 1981.

*Variation of the principal scheme*

2. The Farm Structure (Payments to Outgoers) Scheme 1976(c) shall be varied by substituting in paragraphs 3(2)(a), 11(1) (in the words preceding sub-paragraph (a)), 11(2) and 13(5)(b) for the words “the Farm and Horticulture Development Regulations 1973(d) as amended (e)” the words “any regulations made under section 2(2) of the European Communities Act 1972(f) providing for the payment of grant to a person carrying on an agricultural business as therein defined in accordance with such a plan”.

*(This Note is not part of the Scheme.)*

This Scheme, which applies throughout the United Kingdom, varies the Farm Structure (Payments to Outgoers) Scheme 1976 by substituting for references to certain regulations by name (the Farm and Horticulture Development Regulations 1973, as amended) references to them by a description which also covers other regulations of the same kind, such as the Agriculture and Horticulture Development Regulations 1980 (S.I. 1980/1298).
