**LOCAL GOVERNMENT, SCOTLAND**

**The Local Authorities (Allowances) (Scotland) Amendment  
Regulations 1981**

*Made* - - - - - 5th February 1981  
*Laid before Parliament* 20th February 1981  
*Coming into Operation* 14th March 1981

In exercise of the powers conferred on me by sections 45 and 50 of the Local Government (Scotland) Act 1973(a), and of all other powers enabling me in that behalf, I hereby make the following regulations:—

*Title and commencement*

**1.** These regulations may be cited as the Local Authorities (Allowances) (Scotland) Amendment Regulations 1981 and shall come into operation on 14th March 1981.

*Increase in rates of attendance allowance and financial loss allowance*

**2.** In regulation 3 of the Local Authorities (Allowances) (Scotland) Regulations 1975(b)—

- (a) in paragraph (1) (which prescribes the rate of attendance allowance) for “£13.28” there shall be substituted “£14.00”, and
- (b) in paragraph (2) (which prescribes the rate of financial loss allowance) at sub-paragraph (a) for “£7.00” there shall be substituted “£8.50” and at sub-paragraphs (b) and (c) for the words “£14.00” where they occur respectively there shall be substituted “£17.00”.

*Revocation*

**3.** The Local Authorities (Allowances) (Scotland) Amendment Regulations 1978(c), the Local Authorities (Allowances) (Scotland) Amendment Regulations 1979(d), and the Local Authorities (Allowances) (Scotland) Amendment Regulations 1980(e) are hereby revoked.

## EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These regulations prescribe revised maximum amounts which may be paid to members of any body to which sections 45-50 of the Local Government (Scotland) Act 1973 as amended by paragraph 46 of Schedule 6 to the Local Government (Scotland) Act 1975 (c. 30) apply by way of attendance allowance and financial loss allowance for loss of earnings or additional expenses (other than travelling and subsistence) incurred in the performance of their duties.
