EDUCATION, ENGLAND AND WALES

The Education (Assisted Places) (Incidental Expenses) (Amendment) Regulations 1981

Made -22nd December 1981 Laid before Parliament 11th January 1982 Coming into Operation 1st July 1982

In exercise of the powers conferred on the Secretary of State by sections 18 and 35(4) of the Education Act 1980(a), the Secretary of State for Education and Science, as respects England, and the Secretary of State for Wales, as respects Wales, hereby make the following Regulations:—

- 1.—(1) These Regulations may be cited as the Education (Assisted Places) (Incidental Expenses) (Amendment) Regulations 1981.
- (2) These Regulations shall come into operation on 1st July 1982 but shall not have effect until 1st September 1982 except for the purposes of—
 - (a) determining the questions referred to in Regulation 6 of the principal Expenses Regulations (questions arising under Regulations 3, 4 and 5) in so far as they relate to a school year beginning on or after 1st September 1982, and
 - (b) the payment of uniform grant in pursuance of the proviso to Regulation 3(3) of those Regulations during the two months immediately preceding a pupil's first assisted year where that year begins on or after 1st September 1982.
- 2. In these Regulations a reference to the principal Expenses Regulations is a reference to the Education (Assisted Places) (Incidental Expenses) Regulations 1981(**b**).
- 3. For Regulation 2(1) of the principal Expenses Regulations (Interpretation) there shall be substituted the following provision:-
 - "2.—(1) In these Regulations any reference to the principal Regulations is a reference to the Education (Assisted Places) Regulations 1980(c) as amended by the Education (Assisted Places) (Amendment) Regulations 1981(d).

- 4.—(1) In paragraph (4) of Regulation 3 of the principal Expenses Regulations (uniform grants) for the sum "£5,200" (where it first occurs) there shall be substituted the sum "£5,800" and for sub-paragraphs (a), (b), (c) and (d) there shall be substituted the following provisions:—
 - "(a) £90, where the relevant income does not exceed £5,100;
 - (b) £68, where that income exceeds £5,100 but does not exceed £5,350;
 - (c) £45, where that income exceeds £5,350 but does not exceed £5,550;
 - (d) £23, where that income exceeds £5,550 but does not exceed £5,800;".
- (2) In paragraph (5) of the said Regulation 3 for the sum "£4,800" (where it first occurs) there shall be substituted the sum "£5,350" and for sub-paragraphs (a) and (b) there shall be substituted the following provisions:—
 - "(a) £45, where the relevant income does not exceed £5,100;
 - (b) £23, where that income exceeds £5,100 but does not exceed £5,350".
- 5. In Regulation 4(4) of the principal Expenses Regulations (school travel grants)—
 - (a) in sub-paragraph (a) for the sum "£4,779" there shall be substituted the sum "£5,279", and
 - (b) in sub-paragraph (b) for the sum "£4,600" there shall be substituted the sum "£5,100".
- **6.** In Regulation 5(2) of the principal Expenses Regulations (remission of charges for meals) for the sum "£4,000" there shall be substituted the sum "£4,400".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Education (Assisted Places) (Incidental Expenses) Regulations 1981 ("the principal Expenses Regulations"). The Regulations come into operation on 1st July 1982 but do not have effect until 1st September 1982 except for specified preliminary purposes (Regulation 1).

References to the "principal Regulations", that is to say to the Education (Assisted Places) Regulations 1980, are to be construed as references to those Regulations as amended by the Education (Assisted Places) (Amendment) Regulations 1981 (Regulation 3).

The means tests for uniform grants, school travel grants and the remission of charges for meals are relaxed (*Regulations 4 to 6*).
