LAND DRAINAGE

The Anglian Water Authority (Swavesey Internal Drainage District) Order 1980

Made - - - - - 6th November 1980

Coming into Operation 4th March 1981

Whereas the Anglian Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976(a) in relation to the Swavesey Internal Drainage District;

And whereas the Minister has decided to confirm the Scheme, subject to the modifications set out in Article 2 of this Order;

And whereas a copy of the Scheme with the said modifications incorporated therein is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of every other power enabling him in that behalf, hereby orders as follows:—

1. This Order, which may be cited as the Anglian Water Authority (Swavesey Internal Drainage District) Order 1980, shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed subject to the following modifications:—

- (1) In paragraph 2 of the Scheme there shall be inserted immediately after the words "shown coloured red" the words "and the land in the Parish of Swavesey shown coloured green";
- (2) Paragraph 4 of the Scheme shall be deleted.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Anglian Water Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1976
ANGLIAN WATER AUTHORITY
SWAVESEY INTERNAL DRAINAGE DISTRICT

The Anglian Water Authority (hereinafter referred to as "the Water Authority") pursuant to section 11(1) of the Land Drainage Act 1976 hereby make the following Scheme providing for certain matters referred to in the said section, namely:—

- (i) the constitution of a new internal drainage district consisting of the lands hereinafter mentioned;
- (ii) the constitution of a drainage board for the new internal drainage district;
- (iii) matters supplemental thereto or consequential thereon.

And the Water Authority submit the Scheme to the Minister of Agriculture, Fisheries and Food (hereinafter referred to as "the Minister") for confirmation under section 11(4) of the said Act of 1976.

SCHEME

1. This Scheme shall come into operation on a day to be appointed by the Minister and such day is hereinafter called "the appointed day".

2. On the appointed day all those lands lying in the Parishes of Swavesey and Longstanton in the District of South Cambridgeshire in the County of Cambridgeshire which are shown coloured red and the land in the Parish of Swavesey shown coloured green on the map sealed by the Water Authority in relation to this Scheme shall be constituted an internal drainage district under the name of "the Swavesey Internal Drainage District" (hereinafter referred to as "the Internal Drainage District").

3. There shall be constituted a drainage board for the Internal Drainage District under the name of "the Swavesey Internal Drainage Board" (hereinafter referred to as "the Internal Drainage Board") consisting of seven members who, with the exception of the first members, shall be elected in accordance with the provisions of section 7 of, and Schedule 2 to, the Land Drainage Act 1976. The first members of the Internal Drainage Board shall be persons appointed by the Minister and shall hold office until the expiration of one year from the first day of November next following the day on which they are appointed.
