The Wessex Water Authority (River Avon and **Tributaries Augmentation) Order 1981**

5th May 1981 Made Laid before Parliament 15th May 1981 8th June 1981 Coming into Operation

The Secretary of State for the Environment, in exercise of powers conferred by section 1 of the Water Resources Act 1971(a) and of all other powers enabling him in that behalf, hereby orders as follows:—

1.—(1) This order may be cited as the Wessex Water Authority Citation and (River Avon and Tributaries Augmentation) Order 1981 and shall come commenceinto operation on 8th June 1981.

- (2) This order shall be included among the enactments which may be cited together as the Wessex Water Authority Orders 1974 to 1981.
- 2. The Wessex Water Authority may for the purpose of augmenting Authority to the flow of water in the River Avon and its tributaries discharge water discharge from any borehole specified in Schedule 1 to this order into the water. course set out in, at the point of discharge defined in, and at the rate of discharge described in the said Schedule 1 in respect of each such borehole, and such discharge may be made at any time when the rate of flow in any such watercourse measured at the control point specified in respect thereof in Schedule 2 to this order is less than the rate of flow specified in the said Schedule 2 in relation to such watercourse.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order is made under the Water Resources Act 1971 by the Secretary of State for the Environment, who is the "Minister" by virtue of section 1 of the Water Resources Act 1963 (c. 38) ("the principal Act") and the Secretary of State for the Environment Order 1970 (SI 1970/1681).

The order authorises the Wessex Water Authority to discharge water from boreholes into certain watercourses. Three of the boreholes and three of the discharge points are situated within the area designated by the Cotswold Area of Outstanding Beauty (Designation) Order 1966.
