The Fishing Nets (No. 2) (Variation) (No. 5) Order 1981

The Minister of Agriculture, Fisheries and Food, the Secretaries of State respectively concerned with the sea fishing industry in Scotland and Northern Ireland and the Secretary of State for Wales, acting jointly, in exercise of the powers conferred on them by sections 3, 15(3) and 20(1) of the Sea Fish (Conservation) Act 1967(a) and now vested in them (b) and of all other powers enabling them in that behalf, hereby make the following order:—

Citation and commencement

1. This order may be cited as the Fishing Nets (No. 2) (Variation) (No. 5) Order 1981 and shall come into operation on 30th June 1981.

Variation of principal order

2. The Fishing Nets (No. 2) Order 1980(c) is hereby varied by substituting “31st October 1981” for the date mentioned in article 13 thereof (which specifies the date on which the order is to cease to have effect).
