# **EDUCATION, SCOTLAND**

# The Education (Scotland) Act 1981 (Commencement No. 3) Order 1982

*Made* - - - 26th November 1982

In exercise of the powers conferred on me by section 22(2) of the Education (Scotland) Act 1981(a) I hereby make the following order:—

#### Citation

1. This order may be cited as the Education (Scotland) Act 1981 (Commencement No. 3) Order 1982.

#### Interpretation

2. In this order, "the Act" means the Education (Scotland) Act 1981.

Coming into force of certain provisions of the Act

3. The provisions of this Act specified in Column 1 of the Schedule to this order (the subject matter of each provision being respectively specified in Column 2) shall come into operation, so far as specified in paragraphs 1, 2 and 3 of the Schedule, on 1st January 1983, and so far as specified in paragraph 4 thereof on 5th April 1983.
