## The Tendring Hundred Water (Financial Provisions) Order 1982

Coming into Operation 30th December 1982

The Secretary of State for the Environment, in exercise of the powers conferred by sections 23, 33 and 50 of the Water Act 1945(a) and now vested in him(b), and of all other powers enabling him in that behalf, hereby orders as follows:---

1.-(1) This order may be cited as the Tendring Hundred Water (Financial Citation Provisions) Order 1982 and shall come into operation on 30th December and 1982.

(2) The Tendring Hundred Water Acts and Orders 1884 to 1976 and this order may be cited together as the Tendring Hundred Water Acts and Orders 1884 to 1982.

2. In this order—

Interpretation.

"the Company" means the Tendring Hundred Waterworks Company;

"the Third Schedule" means the Third Schedule to the Water Act 1945.

3. Section 4 of the Tendring Hundred Water (Financial Provisions) Increase of capital and Order 1975(c) is hereby amended borrowing

- (a) in subsection (1) thereof, by substituting, for the words "six million powers. pounds", the words "ten million pounds";
- (b) in the proviso to subsection (3)(a)-
  - (i) in paragraph (i) thereof, by substituting, for the words "the amount", the words "twice the amount";
  - (ii) in paragraph (ii) thereof, by substituting, for the words "five per cent", the words "ten per cent.".

Procedure as to sale of stock.	<ul> <li>4. In its application to the Company's undertaking and its incorporation with the enactments relating thereto, section 75 (which relates to the sale of stock) of the Third Schedule shall have effect subject to the following modifications— <ul> <li>(a) the word "stock" wherever it occurs shall include shares;</li> </ul> </li> </ul>
	(a) the word stock wherever it occurs shall mende shares,
	(b) before the words "the undertakers" in subsection (2) where they occur the second time and in subsection (3) there shall be inserted the words "the directors of"; and
	(c) in paragraph (a) of the proviso to subsection (2) the words "once in each of two successive weeks" shall be omitted.
Repeals.	5. The enactments specified in column (1) of the Schedule to this order are repealed to the extent specified in column (2) of that schedule.
Application of section 94 of Third Schedule.	6. Section 94 of the Third Schedule (which requires undertakers to keep a copy of the special Act at their principal office and to deposit copies with certain officers) is incorporated with this order.
