MARRIAGES, ETC.****The Registration of Births, Deaths and Marriages (Fees)  
(Scotland) Order 1982**

<i>Made</i> - - - - -	15th February 1982
<i>Laid before Parliament</i>	1st March 1982
<i>Coming into Operation</i>	1st April 1982

In exercise of the powers conferred on me by Section 5 of and Schedule 3 to the Public Expenditure and Receipts Act 1968(a) and of all other powers enabling me in that behalf, I hereby make the following order:—

*Citation and commencement*

**1.** This order may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1982 and shall come into operation on 1st April 1982.

*Fees*

**2.** The fees payable under the enactments specified in column 1 of the Schedule to this order in respect of the certificates described in column 2 of that Schedule shall (in place of the amounts previously prescribed which are specified in column 3 thereof(b)) be respectively the amounts specified in column 4 thereof.

*Revocation*

**3.** The Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1980(c) is hereby revoked.
