The Medicines (Prescription Only) Amendment Order 1982

Made - - - - 14th January 1982
Laid before Parliament 21st January 1982
Coming into Operation 11th February 1982

The Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, in exercise of powers conferred by sections 58(1) and (4)(a), 59 and 129(4) of the Medicines Act 1968(a) and now vested in them (b) and of all other powers enabling them in that behalf, after consulting such organisations as appear to them to be representative of interests likely to be substantially affected by this order pursuant to section 129(6) of that Act, and after consulting and taking into account the advice of the Medicines Commission pursuant to sections 58(6) and 129(7) of that Act, hereby make the following order:—

Citation, commencement and interpretation

- 1.—(1) This order, which may be cited as the Medicines (Prescription Only) Amendment Order 1982, amends the Medicines (Prescription Only) Order 1980(c) (hereinafter referred to as "the principal order") and shall come into operation on 11th February 1982.
- (2) In this order, a reference to adding an entry to a column in Part I of Schedule 1 to the principal order, or to adding an entry to Part III of that Schedule, is a reference to inserting that entry at the appropriate point in the alphabetical order of the entries in column 1 of Part I of that Schedule or, as the case may be, of the entries in Part III of that Schedule.

Amendment of Article 3 of the principal order

2. In Article 3(2) of the principal order (duration of restrictions for certain new products), for "three years" there is substituted "five years".

Omission of Article 12 of the principal order

3. Article 12 of the principal order (temporary exemption for administration for certain persons) is omitted.

Amendment of Schedule 1 to the principal order

- **4.**—(1) Schedule 1 to the principal order (descriptions and classes of prescription only medicines) is amended in accordance with paragraphs (2) and (3) of this Article.
- (2) In Part I (which lists ingredients which render a product a prescription only medicine except in circumstances also listed)—
 - (a) there are added to columns 1 and 3 the entries set out in columns 1 and 3 respectively in Schedule 1 to this order;
 - (b) there are omitted from columns 2 and 3 the entries relating to Hexoestrol and to Tretinoin;
 - (c) there are omitted from column 3 the words "Tablets for the" where they occur in relation to Chloroquine Phosphate, to Chloroquine Sulphate and to Hydroxychloroquine Sulphate; and
 - (d) there are inserted in column 3, before "Administration" in the entry relating to Sodium Cromoglycate, the words "Human use:".
- (3) In Part III (which lists particular medicinal products as being prescription only medicines)—
 - (a) the following entries are added:

Amendment of Part III of Schedule 4 to the principal order

- 5. Part III of Schedule 4 to the principal order (exemption from the restriction on administration of prescription only medicines) is amended as follows—
 - (a) in paragraph 2 (exemption for certified midwives) there is inserted after "Pethidine hydrochloride" in column 2 the word "Phytomenadione"; and

(b) after paragraph 8 there is added the paragraph 9 set out in Schedule 3 to this order.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the Medicines (Prescription Only) Order 1980 which specifies descriptions and classes of prescription only medicines, that is to say medicinal products which (subject to exemptions) may be sold or supplied by retail only in accordance with a prescription given by a doctor, dentist, veterinary surgeon or veterinary practitioner and which may be administered only by or in accordance with the directions of such a person.

The amendments made by this Order are as follows:

- (a) the temporary period, specified for the purposes of section 59 of the Medicines Act 1968, during which new products may be prescription only medicines is increased from three to five years from the grant of a licence for the product;
- (b) additions are made to the list of substances which, if contained in a medicinal product, make that product a prescription only medicine (unless it is sold or supplied in specified circumstances), and in relation to some substances amendments are made to the circumstances in which a product, even though it contains that substance, is nevertheless not a prescription only medicine;
- (c) certain named products are specified as prescription only medicines, and other products cease to be so specified by name (their active ingredient being one of the additions to the list of substances referred to above);
- (d) an exemption for administration by certified midwives is extended to include products containing Phytomenadione;
- (e) an exemption (to replace an expired temporary exemption) is granted for the administration of injectable products by certain persons who are not doctors, dentists, veterinary surgeons or veterinary practitioners but who are acting in the course of a business. The exemption does not extend to products that are prescription only medicines for some reason other than that they are injectable.
