In pursuance of sections 35(2) and 40(2) of, and paragraph 23 of Part II of Schedule 3 to, the Local Government Act 1966 (a), I hereby make the following Order:—

1. This Order may be cited as the Betting, Gaming and Lotteries Act 1963 (Variation of Fees) Order 1982 and shall come into operation on 1st June 1982.

2. The sum specified in paragraph 11 of Schedule 2 to the Betting, Gaming and Lotteries Act 1963 (b) (fees in respect of registration as a registered pool promoter) shall, instead of £100, be £350.

3. The sum specified in paragraph 12(1) of Schedule 3 to the Betting, Gaming and Lotteries Act 1963 (fees in respect of application for a track betting licence) shall, instead of £10, be £35.

4. The sum specified in paragraph 12(2) of Schedule 3 to the Betting, Gaming and Lotteries Act 1963 (c) (fees in respect of track betting licence) shall, instead of £100, be £350.

5. The sum specified in paragraph 12(3) of Schedule 3 to the Betting, Gaming and Lotteries Act 1963 (fees in respect of transfer of track betting licence) shall, instead of £10, be £35.

6. In the Schedule to the Miscellaneous Fees (Variation) Order 1968 (d) the entries relating to paragraph 11 of Schedule 2 to the Betting, Gaming and Lotteries Act 1963 and paragraph 12(2) of Schedule 3 to that Act shall be omitted.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the Betting, Gaming and Lotteries Act 1963 so as to increase the maximum amount of certain fees payable under that Act. The maximum amount which may be fixed by the appropriate registering authority as the registration fee and annual continuation fee payable by a registered pool promoter is increased by Article 2. The maximum amounts which may be fixed by the appropriate licensing authority as fees in respect of any application for a track betting licence, the licence itself and any transfer of such licence are increased by Articles 3, 4 and 5.

The maximum amounts which may be fixed as fees for registrations to which Article 2 applies and licences to which Article 4 applies were last increased by the entries in the Miscellaneous Fees (Variation) Order 1968 which are omitted by Article 6 of this Order.
