The Common Agricultural Policy (Wine) Regulations 1982

The Minister of Agriculture, Fisheries and Food and the Secretary of State (a), acting jointly in exercise of the powers conferred on them by section 2(2) of the European Communities Act 1972 and of all other powers enabling them in that behalf, hereby make the following regulations:-

Title and commencement

1. These regulations may be cited as the Common Agricultural Policy (Wine) Regulations 1982 and shall come into operation on 21st May 1982.

Interpretation and revocation

- 2.—(1) In these regulations, unless the context otherwise requires— "the Commissioners" means the Commissioners of Customs and Excise;
- "Community provision" means any provision of any regulation of the European Communities which is referred to in Schedule 1 to these regulations, or of the treaty relating to the accession of the Hellenic Republic to the European Communities signed at Athens on 28th May 1979
- "manufacturing" means using wine, for the purpose of a trade or business (other than a catering business), in the composition, manufacture or preparation of any product;
- "the Minister" means, in relation to England, the Minister of Agriculture, Fisheries and Food and, in relation to Scotland, Northern Ireland or Wales, the Secretary of State;
- "relevant Community provision" means any Community provision referred to in Column 1 or Column 2 of Schedule 2 to these regulations, the subject matter of which is described in Column 3 thereof;
- "retail sale" means any sale to a person buying otherwise than for the purpose of resale but does not include a sale to a caterer in the course of his catering business or to a manufacturer in the course of his manufacturing business;
 - "United Kingdom" means Great Britain and Northern Ireland.
- (2) The Common Agricultural Policy (Wine) Regulations 1979 (c) are hereby revoked.

Enforcement

- 3.—(1) Subject to the provisions of this regulation, local authorities, the Minister, the Commissioners and the Wine Standards Board are hereby designated competent authorities or agencies for the purpose of Community provisions.
- (2) Each local authority shall secure the enforcement and execution of the relevant Community provisions in so far as they relate to the retail sale of wine within its area.
- (3) The Minister, the Commissioners and the Wine Standards Board shall secure the enforcement and execution of the relevant Community provisions in so far as they relate to the importation and exportation of wine to or from the United Kingdom.
- (4) The Minister and the Wine Standards Board shall secure the enforcement and execution of the relevant Community provisions in so far as they relate to any matter not mentioned in paragraphs (2) or (3) of this regulation.
- (5) Nothing in this regulation shall be taken as authorising in the United Kingdom the Wine Standards Board or the Commissioners, or in relation to Scotland only, the Minister or a local authority, to institute proceedings for an offence.
 - (6) In this regulation—
 - (a) "local authority" means—
 - (i) as respects England and Wales, a food and drugs authority for the purposes of the Food and Drugs Act 1955 (a);
 - (ii) as respects Scotland, a regional or islands council which is the enforcement authority for the purposes of sections 1, 2, 6 and 18 of the Food and Drugs (Scotland) Act 1956(b);
 - (iii) as respects Northern Ireland, a district council for the purposes of section 29 of the Food and Drugs Act (Northern Ireland) 1958 (c);
 - (b) "the Wine Standards Board" means the Wine Standards Board of The Vintners' Company.
- (7) The provisions of this regulation are without prejudice to the duties of such local authorities under the provisions of the respective Acts referred to in paragraph (6) of this regulation.

Exemptions from Community labelling provisions

- **4.** The provisions of the relevant Community provisions relating to the information required on labels of the products mentioned in Article 1 of Council Regulation (EEC) No: 355/79(**d**) shall not apply to:—
 - (a) unlabelled products which are transported between two or more establishments or between vineyards and wine making plants, in either case belonging to the same undertaking and situated in the same local authority area;
 - (b) unlabelled quantities of grape musts and wines not exceeding 15 litres per batch and not intended for sale;
 - (c) unlabelled quantities of grape musts and wines intended for the domestic consumption of the producer and his employees.

Offences and Penalties

- 5.—(1) If any person contravenes or fails to comply with any of the relevant Community provisions referred to in Column 1 or 2 of parts I, II or III of Schedule 2 to these regulations, he shall be guilty of an offence and liable on summary conviction to a fine not exceeding one thousand pounds, or on conviction on indictment to a fine.
- (2) If any person contravenes or fails to comply with any of the relevant Community provisions referred to in Column 1 or 2 of parts IV, V or VI of Schedule 2 to these regulations, he shall be guilty of an offence and liable on summary conviction to a fine not exceeding four hundred pounds.

Defence

6. In any proceedings for an offence under these regulations, it shall be a defence for the person charged to prove that he took all reasonable precautions and exercised all due diligence to avoid the commission of such an offence.

Disclosure of information

7. If any person discloses to any other person any information obtained by him in pursuance of his duties under the regulations, unless the disclosure is made in, or for the purposes of, the performance by him or any other person of any function under these regulations, he shall be guilty of an offence and liable on summary conviction to a fine not exceeding four hundred pounds.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These regulations, which apply throughout the United Kingdom and come into operation on 21st May 1982, provide for the enforcement of EEC regulations (as specified in Schedules 1 and 2) concerned with the production and marketing of wine and related products.

The regulations, which re-enact with amendments the Common Agricultural Policy (Wine) Regulations 1979—

- (a) designate competent authorities for the purposes of enforcement (Regulation 3)
- (b) exempt certain products from provisions relating to information required on labels (Regulation 4)
- (c) prescribe offences and penalties (Regulation 5)
- (d) provide for a general defence (Regulation 6)
- (e) prescribe a penalty for unauthorised disclosure of information obtained in pursuance of the regulations (Regulation 7)

The regulations differ from the Common Agricultural Policy (Wine) Regulations 1979 in that—

- (a) the Commissioners of Customs and Excise are designated as an additional competent authority for the purpose of enforcing certain Community provisions (Regulation 3)
- (b) failure to comply with certain Community provisions has been made additionally triable on indictment and the penalties have been altered (Regulation 5)
- (c) the defence provisions have been revised to provide a general defence rather than specific defences by reference to the various Food and Drugs Acts (Regulation 6)
- (d) a penalty is prescribed for unauthorised disclosure of information obtained in pursuance of the regulations (Regulation 7)
- (e) the Schedules have been revised and brought up to date

In Schedule 1 each Regulation is given the title which appears in the Official Journal, except in the case of a Commission Regulation implementing a Council Regulation that has been repealed and superseded. In such a case the title given refers to the superseding Regulation and the title in the Official Journal is given in a footnote.
