The Secretary of State, in exercise of powers conferred by section 101(4) of the Merchant Shipping Act 1970(a) (hereinafter referred to as "the 1970 Act") and now vested in him(b), and of all other powers enabling him in that behalf, hereby makes the following Order:

1. This Order may be cited as the Merchant Shipping Act 1970 (Commencement No. 8) Order 1982 and shall come into operation on 16th July 1982.
2. The provisions of the 1970 Act specified in the first column of the Schedule to this Order (which relate to the matters specified in the second column of that Schedule) shall come into operation on 16th July 1982.

EXPLANATORY NOTE

(This Note is not part of the Order.)

The Order brings into force on 16th July 1982 section 91 of the Merchant Shipping Act 1970 which substitutes new provisions for section 1(5) and (6) of the Merchant Shipping Act 1965 (c.47), enabling the Secretary of State to make Regulations in respect of tonnage measurement and certificates.

It also brings into force on that date the repeal of specified provisions in Part II of the Merchant Shipping Act 1894 relating to certificates of competency and the manning of vessels in so far as they apply to British ships registered in the Channel Islands or the Isle of Man. Jersey, Guernsey and the Isle of Man now have their own statutory requirements on these matters.

NOTE AS TO EARLIER COMMENCEMENT ORDERS

“MSA 1974” means the Merchant Shipping Act 1974(a);

“MSA 1979” means the Merchant Shipping Act 1979(b);
