## The Sheriffs' Fees (Amendment) Order 1982

Made - - 26th January 1982

Coming into Operation 22nd February 1982

The Lord Chancellor, in exercise of the powers conferred on him by section 20(2) of the Sheriffs Act 1887(a), with the advice and consent of the Judges of the Court of Appeal and the High Court, and with the concurrence of the Treasury, hereby makes the following Order:—

1.—(1) This Order may be cited as the Sheriffs' Fees (Amendment) Order 1982 and shall come into operation on 22nd February 1982.

## (2) In this Order-

"the Order of 1920" means the Order made under section 20(2) of the Sheriffs Act 1887 and dated 8th July 1920(b); and

"the Order of 1921" means the Order made under the same section and dated 2nd May 1921(c).

- 2. In Fee No. 1 in the Table of Fees set out in the Schedule to the Order of 1920, for the words "16.4 pence" there shall be substituted the words "22.3 pence".
- 3. In Fee No. 7A in the Table of Fees set out in Part I of the Schedule to the Order of 1921, for the words "16.4 pence" there shall be substituted the words "22.3 pence".
- 4. The Sheriffs' Fees (Amendment) Order 1975(d), the Sheriffs' Fees (Amendment) Order 1977(e), and the Sheriffs' Fees (Amendment) Order 1979(f) are hereby revoked except in respect of any fee demanded, taken, or received before the commencement of this Order.
