The Education (Grants) (Music and Ballet Schools) (Amendment) (No. 2) Regulations 1983

Made - - - - 14th July 1983

Laid before Parliament 28th July 1983

Coming into Operation 1st September 1983

In exercise of the powers conferred by section 100(1)(b) and (3) of the Education Act 1944(a) and vested in the Secretary of State (b), the Secretary of State for Education and Science hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Education (Grants) (Music and Ballet Schools) (Amendment) (No. 2) Regulations 1983 and shall come into operation on 1st September 1983.
- 2.—(1) In these Regulations a reference to the principal Regulations is a reference to the Education (Music and Ballet Schools) Regulations 1981(c).
- (2) These Regulations shall be construed as one with the principal Regulations.
- **3.**—(1) Regulation 4(2) of the principal Regulations (reference to a school confined in the case of the Royal Ballet School to the Lower Division thereof) is hereby revoked.
- (2) A child holding an aided place in the Lower Division at the Royal Ballet School immediately before 1st September 1983 shall be treated for the purposes of the principal Regulations and the Aided Pupil Scheme specified in Schedule 1 thereto as if he had been selected to hold an aided place in the Lower and Upper Divisions at that school unless, before 1st October 1983, the school notify his parent that he will cease to be an aided pupil on leaving the Lower Division.

- **4.** At the end of paragraph 3 of Schedule 2 to the principal Regulations (conditions of payment of grant) there shall be added the following provision:—
 - "(3) An aided place to be first taken up in the Upper Division at the Royal Ballet School shall only be granted—
 - (a) to a child in the Lower Division about to transfer to the Upper Division thereof, or
 - (b) to a child in the Upper Division who transferred thereto from the Lower Division thereof on or after 1st September 1983.".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Education (Music and Ballet Schools) Regulations 1981 in their application to the Royal Ballet School.

That school is divided into Upper and Lower Divisions and the aided pupil scheme set out in the 1981 Regulations applies only in relation to the Lower Division. The present Regulations remove this limitation (*Regulation 3(1)*).

Children now holding aided places in the Lower Division will continue to hold such places when they transfer to the Upper Division unless their parents are notified to the contrary before 1st October 1983 (Regulation 3(2)).

Aided places to be first taken up in the Upper Division are, however, restricted to children who transfer thereto from the Lower Division on or after 1st September 1983 (Regulation 4).
