#### The Companies (Forms) Regulations 1983

14th July 1983 Made Coming into Operation 1st January 1984

The Secretary of State, in exercise of the powers conferred by those sections of the Companies Acts specified in Schedule 1 hereto, and now vested in him(a), hereby makes the following Regulations:-

- 1.—(1) These Regulations may be cited as the Companies (Forms) Regulations 1983 and shall come into operation on 1st January 1984.
- (2) In these Regulations "the Companies Acts" means the Companies Act 1948, the Companies Act 1976 and the Companies Act 1980.
- 2.—(1) The forms numbered 1, 7, 9b, 19, 47, 47a, 47c, 48, 49, 49a, 49b, F1, F8, F9, F10, F11, F12, F12a and F12b and set out in Schedule 2 hereto shall be substituted for the forms respectively bearing those numbers set out in Schedule B to the Companies (Forms) Regulations 1979(b) and the particulars contained therein are the particulars prescribed for the purposes of the provisions of the Companies Acts referred to therein.
- (2) The prescribed manner for the certification of a copy of any document referred to in section 407(1)(a) of the Companies Act 1948 shall be the manner specified in note 1 to the form numbered F1 set out in Schedule 2 hereto.
- (3) The prescribed manner for the certification of a translation of any document referred to in section 407(1)(a) of the Companies Act 1948 shall be the manner specified in note 2 to the form numbered F1 set out in Schedule 2 hereto.
- 3. The forms numbered 15, 16, 17 and 18 set out in Schedule 3 hereto with such variations as circumstances require are the forms prescribed for the purposes of the provisions of the Companies Acts referred to therein and the forms numbered 21 and 23 set out in Schedule B to the Companies (Forms) Regulations 1979 and those numbered 17b, 17c, 17d, 18b and 18c set out in Schedule B to the Companies (Forms) Regulations 1980(c) are hereby revoked.

# Notes for guidance on the completion of the form of annual return of a company not having a share capital

#### Indebtedness

1 Section 125(2) of the Companies Act 1948 requires that a statement be annexed to this return of the total amount of indebtedness of the company in respect of all mortgages and charges which are required to be registered with the Registrar of Companies under the Companies Act 1948 or which would have been required so to be registered if created after 1 July 1908. If the company is registered in Scotland the indebtedness of the company in respect of all mortgages and charges which would be required to be registered with the Registrar of Companies had the company been registered in England should be inserted, including those which would have been required so to be registered if created after 1 July 1908. The total amount of indebtedness may be entered in the appropriate box on page 1.

#### Register of members and debenture holders

2 If the register of members or any register of debenture holders is kept otherwise than in a legible form (eg on computer) the Companies (Registers and other Records) Regulations 1979 (SI 1979/53) made under section 3 of the Stock Exchange (Completion of Bargains) Act 1976 requires notification in the annual return of the place in Great Britain where such register may be inspected if that place of inspection is elsewhere than at the registered office.   - (b) a body corporate of which the company making the return was a wholly owned subsidiary;
  - (c) a wholly owned subsidiary of the company making the return; or
  - a wholly owned subsidiary of a body corporate of which the company making the return was also a wholly owned subsidiary.



#### **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

#### These Regulations:—

- (a) provide that the forms set out in Schedule 2 to the Regulations are prescribed for the purposes of the provisions of the Companies Acts 1948 to 1980 referred to therein, in place of the forms bearing the same number which are set out in Schedule B to the Companies (Forms) Regulations 1979;
- (b) prescribe the manner for the certification of a copy of any document referred to in s. 407(1)(a) of the Companies Act 1948 and of any translation of such a document;
- (c) prescribe a form for the statements required by section 382(3) of the Companies Act 1948 and prescribe certain new forms for the purpose of applications for the registration of unregistered companies under Part VIII of the Companies Act 1948 in place of forms 21 and 23 in Schedule B to the Companies (Forms) Regulations 1979 and forms 17b, 17c, 17d, 18b and 18c in Schedule B to the Companies (Forms) Regulations 1980;
- (d) prescribe the form of a return of allotments required by section 52(1)(a) of the Companies Act 1948 when the shares allotted are bonus shares. The allotment of bonus shares is not a transaction chargeable to capital duty so that regulation 4(3) of the Companies (Forms) Regulations 1979 does not in that case supply an appropriate form.
