**The Companies Act 1981 (Commencement No. 5)
Order 1983**

Made - - - - - 14th July 1983

Coming into Operation 1st January 1984

The Secretary of State, in exercise of the powers conferred on him by section 119(3) of the Companies Act 1981(a), hereby makes the following Order:—

1. This Order may be cited as the Companies Act 1981 (Commencement No. 5) Order 1983.

2. The following provisions of the Companies Act 1981 shall come into operation on 1st January 1984:—

- (a) section 95;
- (b) section 119(4) (so far as it relates to paragraph 13(b) of Schedule 3) and the said paragraph 13(b); and
- (c) section 119(5) and Schedule 4 so far as they provide for the repeal of
 - (i) section 16(3) of the Companies Act 1967(b), and
 - (ii) the entry in Schedule 2 to the Companies Act 1980(c) relating to section 200 of the Companies Act 1948(d).

EXPLANATORY NOTE

(This Note is not part of the Order.)

Certain provisions of the Companies Act 1981 have been brought into force by the Companies Act 1981 (Commencement No. 1) Order 1981 (S.I. 1981/1621), the Companies Act 1981 (Commencement No. 2) Order 1981 (S.I. 1981/1684), the Companies Act 1981 (Commencement No. 3) Order 1982 (S.I. 1982/103) and the Companies Act 1981 (Commencement No. 4) Order 1982 (S.I. 1982/672).

This present Order brings into operation on 1st January 1984,

- (a) section 95 (register of past directorships);
- (b) section 119(4), so far as specified in Article 2 of the Order, and paragraph 13(b) of Schedule 3; and
- (c) section 119(5) and Schedule 4 (repeals) so far as specified in Article 2 of the Order.
