In exercise of the powers conferred on me by section 5 of, as read with paragraph 3 of Schedule 3 to, the Public Expenditure and Receipts Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

- 1. This order may be cited as the Lyon Court and Office Fees (Variation) Order 1983 and shall come into operation on 24th August 1983.
- 2. The fees in Schedule B to the Lyon King of Arms Act 1867(b) in respect of each of the matters specified in column 1 of the Schedule to this order shall be amended by substituting for the sum specified in respect of that matter in the said Schedule B (being the sum specified in column 2 of the Schedule to this order) the sum specified in respect thereof in column 3 of the Schedule to this order.
- 3. The Lyon Court and Office Fees (Variation) Order 1981(c) is hereby revoked.
