**The Housing (Northern Ireland Consequential Amendments)
Order 1983**

Whereas a draft of this Order has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, in exercise of the powers conferred by section 38(2) of the Northern Ireland Constitution Act 1973(a) as extended by paragraph 1(7) of Schedule 1 to the Northern Ireland Act 1974(b), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

Title, commencement and extent

1. This Order—

- (a) may be cited as the Housing (Northern Ireland Consequential Amendments) Order 1983;
- (b) shall come into operation on the same day as the Housing (Northern Ireland) Order 1983(c); and
- (c) extends to the whole of the United Kingdom.

Amendment of Housing Act 1980

2.—(1) The Housing Act 1980(a) shall be amended in accordance with the following provisions of this Article.

(2) In section 111(8) (exclusion of certain recommendations made to building societies from the scope of section 16(3) and (5) of the Restrictive Trade Practices Act 1976(b)):

- (a) after the words “this section” there shall be inserted the words “or under Article 156 of the Housing (Northern Ireland) Order 1981” and
- (b) after the words “Secretary of State” there shall be inserted the words “or of the Department of the Environment for Northern Ireland, as the case may be,”.

(3) In section 155(3) (provisions extending to Northern Ireland), after the word “Sections” there shall be inserted “111(8),”.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order makes amendments to the Housing Act 1980 which are expedient in consequence of Article 87 of the Housing (Northern Ireland) Order 1983. That Article amends the Housing (Northern Ireland) Order 1981 (S.I. 1981/156 (N.I. 3)) by substituting for Article 156 of that Order a new Article.

The effect of Article 2(2) and (3) is to exclude from the scope of section 16(3) and (5) of the Restrictive Trade Practices Act 1976 certain recommendations which may be made to building societies about entering into indemnity agreements with the Northern Ireland Housing Executive.
