BETTING, GAMING AND LOTTERIES

The Gaming Act (Variation of Fees) Order 1983

In pursuance of sections 48(5) and 51(4) of the Gaming Act 1968(a), I hereby make the following Order:—

1.—(1) This Order may be cited as the Gaming Act (Variation of Fees) Order 1983 and shall come into operation on 1st April 1983.

(2) This Order shall not extend to Scotland.

2. The provisions of section 48 of the Gaming Act 1968 specified in the first column of the Schedule to this Order (which relate to fees charged in respect of the matters mentioned in the second column of that Schedule) shall have effect as if, for the references to the sums specified in those provisions (for which the sums mentioned in the third column of that Schedule were substituted by the Order revoked by this Order), there were substituted references to the sums specified in the fourth column thereof, respectively.

3. Section 48(3)(h) of the Gaming Act 1968 (which relates to the fee to be charged for the grant or renewal of a permit for premises where gaming machines are used) shall continue to have effect with the substitution for the reference to the sum specified in that provision of a reference to the sum of £8.50.

4. The Gaming Act (Variation of Fees) Order 1982(b) is hereby revoked.

Article 3 consolidates into this Order the provision relating to the only other fee increased by the Gaming Act (Variation of Fees) Order 1982, which Order is revoked by Article 4.
